Description and Eligibility

The Delaware Coalition of Nurse Practitioners is pleased to announce their annual NP Education Scholarships. Two scholarships will be awarded to registered nurses who are attending a BSN-MSN, BSN-DNP, MSN-DNP or a Post-Graduate NP nursing program. Each scholarship will be \$1000. The deadline for applying for the scholarship is May 1, 2022.

Award recipients will be notified by June 1, 2022 and will be expected to attend a future meeting of the Delaware Coalition of Nurse Practitioners to accept the scholarship.

Purpose of the award: To support the education endeavors of our Advanced Practice Nurses and Advanced Practice Nurse Students.

Eligibility Requirements:

- Active enrollment in a BSN-MSN, BSN-DNP, MSN-DNP or Post-Graduate NP nursing program
- Current active regular membership or student membership in the Delaware Coalition of Nurse Practitioners
- Cannot have received DCNP Scholarship in the past
- Support of the DCNP through regular attendance at meetings will also be taken into consideration
- Recipients are required to provide a brief presentation related to the focus of their advanced practice education, or their DNP project at a future DCNP meeting

LEGISLATIVE UPDATE

Legislation Matters....

Hi everyone. The DE Legislature continues in full swing until June 30, 2022. A number of bills in the DE Legislature impact the healthcare of Delawareans so Legislation Matters to NPs and the care of our patients.

Below are some bills related to healthcare currently under consideration in the Delaware Legislature. We are in the 2nd year of the legislative session so if a bill does not progress (get through House and Senate Committee and both the full House and Senate chambers then signed by the Governor) it would have to be resubmitted next year if there is interest by the sponsor. Each entry gives a number of the bill, brief information about who is supporting this with contact information and a link to read the whole bill.

Your board members of the Delaware Coalition of Nurse Practitioners have reviewed some of the bills and their position is noted. Also noted is the position of the Delaware Nurses Association when known. We hope each of you will take an interest in following and commenting on laws and regulations that impact the

way we practice. There are more than 1,100 licensed NPs in Delaware and when we all speak we do make a difference.

Original Synopsis: This Act, the Healthy Delaware Families Act, creates a statewide paid family and medical leave insurance program. Delaware employees can access up to 12 weeks of paid family and medical leave through the State's paid leave trust fund for a qualifying event, including for the following: (1) To address a worker's own serious health condition. (2) To care for a family member with a serious health condition. (3) To bond and care for a new child. (4) To address the impact of a family member's military deployment. This Substitute to Senate Bill No. 1 differs from Senate Bill No. 1 with regard to the eligibility determination process, covered relationships, length of leave, forms of leave covered, cumulative leave, eligibility criteria, implementation timeline, appeal process, departmental powers, and not requiring participation from certain smaller businesses. This Substitute differs from Senate Substitute No. 1 to Senate Bill No. 1 by making technical corrections, clarifying intent and providing greater statutory detail with regard to appeals, coordination of benefits, definitions, private plans, and departmental powers, and providing temporary flexibility regarding implementation.

Original Synopsis:

This Act permits a terminally ill individual who is an adult resident of Delaware to request and self-administer medication to end the individual's life in a humane and dignified manner if both the individual's attending physician or attending advanced practice registered nurse (APRN) and a consulting physician or consulting APRN agree on the individual's diagnosis and prognosis and believe the individual has decision-making capacity, is making an informed decision, and is acting voluntarily.
