

The Kiefer Foundation (“us”, “we”, or “our”) operates <https://mkiefer.org/> (the “Site”). This page informs you of our policies regarding the collection, use and disclosure of Personal Information we receive from users of the Site.

## **Information Collection**

---

You can use our Site without providing your Personal Information. You are not required to provide Personal Information as a condition of using our Site, except as may be necessary to provide you a product or service at your request.

While using our Site or our partner site(s), we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you. Personally identifiable information may include, but is not limited to your name, your e-mail, your telephone number, and other personal information voluntarily provided by you, on our Site for contact or promotional purposes.

Your use of the Site and/or the provision of your Personal Information, including Personal Information provided in connection with any contest, constitutes your consent to the collection, use, storage, processing and transfer of that information in accordance with this Privacy Policy.

## **Collection And Use of Information**

We collect Personal Information only when you provide it to us, through donations, taking the pledge, participating in contests, completion of forms or emails, requests about the Site, and similar situations in which you have chosen to provide information to us. We use Personal Information for providing services and improving the Site, or as may be required by law.

We will not sell or give any Personal Information to any third parties except as provided for below, or with your express consent:

If you choose to donate to the Kiefer Foundation, your credit card and financial information will be used only for billing purposes and to contact you if there is an

issue with processing the donation. A credit card processing company is used to bill users for donations. This company does not retain, share, store, or use personal information for any secondary purpose beyond filling your order.

If you choose to participate in a contest sponsored by us, your personal information may be used by us, or by the third party organizing the contest, to contact you if you are determined to be the winner of the contest.

We may be required by law enforcement or judicial authorities to provide personally identifiable information to the appropriate governmental authorities. If requested by law enforcement or judicial authorities, we will provide this information on receipt of the appropriate documentation.

We may also release Personal Information to law enforcement agencies or other third parties if we feel it is necessary to protect the safety and welfare of our personnel or to enforce our terms of use.

## **Communications**

---

We may use your Personal Information to contact you with newsletters, marketing or promotional materials, contact you if you are the winner of a promotion, and provide other information that we periodically send subscribers.

If at any time you do not wish to receive this information from us, we ask that you [CONTACT US](#) with this request and we will remove you from our mailing lists.

## **Cookies**

---

Cookies are files with small amount of data, which may include an anonymous unique identifier. Cookies are sent to your browser from a web site and stored on your computer's hard drive. Like many sites, we use "cookies" to collect information. You can instruct your browser to refuse all cookies or to indicate

when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Site.

## **Security**

---

The security of your Personal Information is important to us, but remember that no method of transmission over the Internet, or method of electronic storage, is 100% secure. While we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.
