The Canvassing Board will meet at the Supervisor of Elections Office, 213 Palafox Place, 2nd Floor, Pensacola on the following times and dates to process vote-by-mail ballots and perform any other duties that may be prescribed by law.

9:00 a.m., Tuesday, November 6, 2018 and reconvene at 3:00 p.m. - process vote-by-mail ballots, canvass precinct results, and perform any other duties that may be prescribed by law.

3:00 p.m., Thursday, November 8, 2018 - process provisional ballots and, if concluded, file 1st unofficial results, and perform any other duties that may be prescribed by law.

9:00 a.m., Friday, November 9, 2018 - **if necessary,** continue processing provisional ballots, file 1st unofficial results, and perform any other duties that may be prescribed by law.

9:00 a.m., Thursday, November 15, 2018 - if necessary, file 2nd Unofficial Results.

2:00 p.m., Friday, November 16, 2018 – Process 10-day ballots, certify election, file Conduct of Election Report, random selection of contests and precincts for post-election audit.

10:00 a.m., Monday, November 19, 2018 - Conduct Post Election Audit

Sealed vote-by-mail ballots for the General Election, November 6, 2018, will be available for public inspection one hour prior to each meeting in which they are processed. On Election Day, sealed vote-by-mail ballots will be available for public inspection prior to processing.

If so, the location, date and time will be announced at the conclusion of the pertinent meeting, posted online at EscambiaVotes.com and posted on the doors at the Supervisor of Elections Office, Escambia County Administration Building, Pensacola City Hall and Century City Hall.
