Our nation's ability to compete and lead in a rapidly changing global economy is closely related to our leadership in the development and effective use of standards and standardization processes.


Standards provide the common language that keeps domestic and international trade flowing. It is difficult to overestimate their critical value to both the U.S. and global economy.

U.S. Standardization System guiding principles

- Standards should meet societal and market needs and should not be developed to act as barriers to trade
- SDOs should avoid duplication of, and overlap with, the work of other standardizing bodies
- The U.S. endorses the globally accepted standardization principles of the World Trade Organization Technical Barriers to Trade Agreement

 - Openness
 - Impartiality
 - Effectiveness and relevance
 - Consensus
 - Performance-based

U.S. Standardization System government's role

- The U.S. federal government is the largest single creator and user of specifications and standards
- Decisions about which standards are most appropriate for specific needs are left to the discretion of individual agencies
- The National Technology Transfer and Advancement Act requires federal government agencies to use voluntary consensus standards for regulatory and procurement purposes whenever possible, in lieu of creating government unique standards



U.S. Standardization System conformity assessment

- Standards are just good ideas unless products, processes, systems, and personnel conform to them.
- Conformity assessment activities in the U.S. are not centrally organized
 - Activities are a mix of government (both regulatory and voluntary programs) and private sector (market-based programs)
 - Approaches vary among sectors





- The American National Standards Institute serves as administrator and coordinator of the private sector standardization system in the United States.
- Founded in 1918, ANSI is a private, non-profit organization.
- ANSI is not a government agency or a standards developer.

ANSI's Engagement with European Standards Organizations (ESOs)

- CEN, CENELEC, and ETSI are counterparts to ISO, IEC and ITU
- CEN the European Committee for Standardization, produces European standards in all areas except for electrotechnical and telecommunications
- CENELEC, the European Committee for Electrotechnical Standardization, works to produce a single set of harmonized electrotechnical standards in Europe
- ETSI, the European Telecommunications Standards Institute, determines and produces European telecommunications standards
- ANSI interacts with the ESOs in various ways, including conducting over 30 ANSI-ESO dialogues since 1989

- ANSI coordinates and leads outreach visits to and from countries of interest on an ongoing basis
- Outreach visits may be bilateral delegation meetings with ANSI peer national standards bodies (NSBs), their members, and/or with NSB staff either abroad or in the U.S.
- ANSI and USNC of IEC annually participate in a significant number of bilateral meetings with countries all over the globe, hosting many in ANSI's offices. This leads to better coordination and cooperation regionally and internationally.

ANSI's International Development Activities

Funding provided by U.S. Trade and Development Agency (USTDA)

 Helps maintain policies and positions of U.S. standards and conformance community in the implementation of U.S. government-funded projects

U.S.-China Standards and Conformance Cooperation Program (SCCP) (2016-2018)

- 20 workshops in China conducted over 3-year period
- Workshops will cover a wide range of sectors, relevant issues related to standards and conformity assessment

U.S.-Africa Clean Energy Standards Program (CESP) (2016-2019)

- 5 workshops in Sub-Saharan Africa in second phase, with an option for a third phase
- Workshops cover standards related topics for clean energy technologies



ANSI's International Development Activities

- Standards Alliance (2013-2021)
 - A public-private partnership supported by USAID and ANSI
 - Designed to build capacity of developing countries to implement the WTO Agreement on Technical Barriers to Trade (TBT)
 - Includes up to ten (10) participating countries: CAFTA-DR,
 Colombia, EAC, Indonesia, Mexico, MENA, Peru, SADC,
 Vietnam, Yemen
 - Expanded in 2016 to include 5 additional African countries
 - Opportunities for ANSI members to participate as experts in project training and other activities
