# Avrek Law Firm

**SEVERAL MONTHS AGO**, a 4-year-old boy was playing hide-and-seek at dusk outside of a condominium complex. He ran across the street near a light pole and was hit by a car. The driver fled but was caught and arrested by police. The boy suffered a serious traumatic brain injury.

Maryam Parman, managing partner of Avrek Law Firm, learned that the driver carried only \$15,000 in coverage on his auto insurance policy, which would not come close to paying for the child's medical needs. Ms. Parman and her team visited the scene of the accident and discovered posted signs that discouraged children from playing inside the complex, a violation of the Fair Housing Act. That discovery led to a unique theory for recovery. She contacted the condo complex's insurance company and obtained \$5 million for the child and his family. The settlement is being submitted for court approval.

Ms. Parman says the case represents one of her firm's most significant accomplishments. "This shows how we think outside of the box on these catastrophic injury cases."

That result is just one of the many successful cases that have been conducted by Avrek Law, a personal injury firm with years of experience in helping individuals throughout the State of California.

Avrek Law includes several members of Parman's family. "My two younger sisters are attorneys, my stepdaughter just finished taking the Bar, another one is leaving us to start law school this month," Parman says. Avrek Law Firm is owned and managed by mostly women, "so

there is definitely a different feel from the typical injury firm," she adds. "But what is most impressive to me is that we've been able to prevail in cases that other attorneys have turned down."

Parman has handled thousands of personal injury cases during her 16-year career. She and her colleagues at Avrek have represented their clients in personal injury, product liability, wrongful death, insurance bad faith, police brutality and catastrophic injury cases, winning more than \$100 million in settlements and court judgments since 1998. Less than 1 percent of U.S. lawyers are members.

Ms. Parman originally wanted to pursue a career in medicine. While working as an intern at a personal injury law firm, she discovered that personal injury law was her calling. After getting a near perfect score on her Law School Admission Test, she secured a fellowship to attend law school.

Her decision to switch careers was a life-defining decision, she says. "I love what I do for my clients. I find it personally rewarding and I can't imagine doing anything else with my life".
