# New studio opening inside Performing Arts Dance

With a new school year comes the start of after-school activities, headlined by sports such as high school and Little Loop football, soccer and volleyball.

And while it may not get as much attention, dance still remains a popular after-school choice for children and teens everywhere — so much so that Performing Arts Dance Academy owner and executive director, Hamburg native Suzanne Mall, will be opening a new studio in its Lake Street location this September.

"We're just so proud of it," she said. "I'm excited to see what's going to happen."

The new studio space in the Lake Street plaza is adjacent to Studio B Dancewear, which Mall also owns. Mall explained that the addition will allow for approximately 450 students to be part of more individualized, skill level-based classes as opposed to grouping students with varying dance experience together in one class.

"It was hard to have just the two studios; we want to be able to challenge our kids that want to go on (to do this) professionally," she said. "You always have those kids that have it in their heart and we have a group of really strong, dedicated children that want to go on and dance."

The new studio will also allow the business to expand to being open six days a week.

Mall noted that while the idea of a third studio had been on her mind for some time, she was unable to find the right kind of space for the project until the Hamburg Pharmacy passed on the opportunity to take over the vacant attorney's office in the plaza.

It allowed Mall to sign a lease in March. Her husband, Tom, did all of the construction work in the old office, turning it into a bright, airy studio with an 18-foot soundproof wall, coffee station and bathroom.

"I never thought this would be possible," Mall said. "This is like a miracle to us, because we never thought we would have it here on Lake Street."

In addition to the new studio, the academy will offer a new character dance class, joining the list of offerings alongside classical ballet, pointe, contemporary, combo, tap, jazz, conditioning, hip-hop, break-dancing and musical theater.

On top of the physical benefits of dance, Mall emphasized the positive social learning that takes place in her classrooms, as well as imparting values of respect and discipline to students.

"Kindness is really important

develop relationships with people outside of their own circle," she said. "I think that's really big."

The 23-year-old company features an expansive class list, due largely to having 12 teachers with a range of experience. They include Mall's daughters, Kristen Weigel and Kerri Paufler, who became co-owners in January.

While Weigel belonged to Zodiac Dance Company, she never considered dance as a professional option, instead obtaining a bachelor's degree in sociology from the State University at Buffalo. However, after one summer in social work and a few others jobs, she came home to her mother's company and found her true career path.

"It was like, 'I think this is what I want to do.' I wanted to stay at the studio — that's where I could work with kids as I imagined originally with social work," she said. "It's really cool."

Paufler, however, always pursued dance professionally, attending the American Music and Dramatic Academy in New York and landing a role in the 25th anniversary national tour of "Cats."

She also teaches private performance lessons at the studio and recently recorded a Christian contemporary album, "Broken to Beautiful."

Paufler emphasized her own excitement about the sense of physical and emotional well-being that she hopes students are able to obtain through their classes in the new studio.

"I think it's going to be a space where the kids not only grow in dancing, but grow in who they are as individuals," she said. "I'm hoping that they'll be able to see themselves as God sees them, that they're beautiful creations. In dance,

sometimes, self-image can be a little distorted, so I'm praying that it'll be a space where they can learn to love themselves."

While Mall hasn't taught at her business since 2008, she has her own storied history of involvement with dance. Trained by a Russian teacher in classical ballet, Mall said she was always passionate about dance, but found herself losing touch with the field after getting married at 21 and having three children by age 29.

"It was like, 'Why didn't I pursue it?" she said. "I went through a very emotional time."

After some encouragement by a fellow church member who owned her own dance company, Mall made the decision to get back into dance and began performing with the highest level group. Mall's talent landed her the lead role in the company's "Snow Queen" performance at Shea's.

"It was amazing to be a mother that was in her 30s and be able to do that," she said.

Mall went on to perform with the Buffalo City Ballet until she was almost 40 and noted that her own journey to carry her love of dance beyond the "regular" studio age inspired her to create a new, weekly Christian worship and dance ministry group for older women this fall.

"I started the business as a divorced mother raising three kids, and that's why it's such a miracle to me — I had nothing. All I could think was, 'What am I going to do?" she said. "But I thought that the only thing was to move forward and that if I had nothing to lose, I might as well go for it."
