Bakery and more expands with site in Hamburg Village Plaza

When September comes around, thoughts of outdoor barbecues and chilled drinks are replaced by tantalizing images of warm coffees and teas, savory soups and pumpkin-spiced goods.

And of course, the piece de resistance of autumn: good old-fashioned, homemade

Fortunately, Mr. Pot Pie has opened up shop and is happy to cater to all of these comfort food desires.

An offshoot of the family-run McDuffie's Bakery in Clarence, Mr. Pot Pie opened its third store in June in the Hamburg Village Plaza its other location is in East Aurora. The store held a ribbon-cutting, grand-opening ceremony Aug. 30.

"People have been asking me for years to open a retail store in Hamburg — there's really no competition in town," owner Brian Thomas said.

Thomas has been a vendor at the Hamburg Farmers Market for 10 years, allowing him to establish a solid customer base before the brick-andmortar shop opened.

While McDuffie's originally only worked in wholesale production of all-natural Scottish shortbread cookies, the idea to create a retail bakery came about in 2010 when Thomas and his father, founder Dave, decided to turn 500 square feet of unused office space in the Clarence facility into a store.

"We went into it with real low expectations, but within two weeks we saw that people really wanted to have a bakery," Brian Thomas said.

Thomas found that customers were clamoring for a local retail bakery, with shops like Pumpernick N' Pastry having to close their doors due to competition with chain grocery bakeries.

"Since supermarkets have got involved with in-store bakeries, that's really hurt retail bakeries," Thomas said. "It's tough for a stand-alone retail bakery to make it. We're fortunate that we have the wholesale part of it that covered all the overhead."

Starting only with their shortbread cookies and locally sourced coffees, Thomas listened to customer feedback and hired a pastry chef to meet the demand for specialty breads, coffee cakes and pastries, which he said he originally "had no idea how

What Thomas did know how to do well, though, was make a mean pot pie. Using his mother's homemade recipe to initially offer a classic, frozen chicken pot pie, Thomas was stunned to see how quickly the pies were selling out.

"It kind of threw us for a loop," he said.

However, Thomas and his staff rose to the challenge, coming out with a unique variety of "conveniently delicious" frozen pot pies combining quality ingredients with easy prep for busy customers.

The menu rotates through 10 pot pie flavors a month, with current offerings including chicken, chicken cheddar broccoli, steak and Guinness, seafood, fiesta BBQ chicken, chicken curry, shepherds pie, turkey bacon gouda, fall-favorite butternut squash and "Pie of the Month" beef taco.

While the chicken and seafood pies come in individual sizes, all other pot pies are a full 9 inches. All pies except for the full seafood (\$26.95) are

If you're not a pie person, though, you still have plenty of lunch and dinner options with quiches, chicken marsala, chicken cordon bleu. stuffed chicken breasts and macaroni and cheese.

And if you want to pair your entrée with a side, look no further than one of the store's 40 homemade soups, with two rotating flavors available daily, as well as chili. Popular flavors include loaded baked potato, Italian weaaing, cnee: tomato basil.

For dessert this fall, try one of the shop's upcoming pumpkin-flavored coffee cakes or pies.

While Thomas admitted that it's always a challenge "keeping food costs in line," the dedication of his staff and pastry chefs consistently keep the products coming out fresh and inventive, and are largely influenced by changes in seasonal ingredients and

"We've got a really good team right now," he said. Aside from the food,

Thomas places his focus on ensuring that anyone who walks through the door of his store feels right at home.

"The customer service that you get from a family-run business is going to be far superior to any chain," Thomas said. "I'm in each store everyday talking to customers, and I think of so many of them like family — I know probably half of my customers by name. And consumers' money stays local when you buy from a family-operated

While Thomas has been fully immersed in the business for decades and loves his job, the bakery game wasn't part of his career plan — he graduated from SUNY Oswego with a bachelor's degree in criminal justice.

'I was going to work at the bakery temporarily until I found a job in law enforcement, but here I still am," he said. "I enjoy it."

Mr. Pot Pie is open 9 a.m. to 7 p.m. Monday through Friday and from 9 a.m. to 6 p.m. Saturday. For more information, call the store at 202-1717.

Bowers recognized for work in Flower Show at Fair


