Adamchick CPA & Associates expands business into Hamburg

While filing one's taxes may be the last thing on most people's mind in September, it's something that Mark Adamchick of Adamchick CPA & Associates is thinking

While the Hamburg High School graduate originally started doing taxes and accounting out of his home in 2008, his passion for the industry led to a natural expansion to a brick-andmortar office in Springville and recently to the February opening of a second office at 6175 South Park Ave. in Hamburg. The official ribbon-cutting ceremony took place Sept. 16.

"I live in between the two, so this is perfect," Adamchick said. "It's gone really well.'

After "maxing out" services at around 850 to 900 tax returns in his Springville office, Adamchick looked for a Hamburg location for roughly eight months before his marketing manager came across the site that was ready to go within two weeks of moving in.

"Once we got in, the building was pretty much set," Adamchick said. "It's very convenient and we have a great landlord.'

While Adamchick's business has surged in the past decade, he noted that he initially only did 50 returns in his first year of self-employment. In addition to seven different tax services and accounting, the business has evolved to offer auditing, bookkeeping, financial statement review, and payroll services year-round.

"The biggest challenge was the risk of, 'Hey, I'm used to having a paycheck every week' and you get to that point of needing to make money every week that was the scariest part," Adamchick said of starting his own company. Now, with over 25 years of collective industry experience, he notes that while challenges have decreased, "hard work" is always a constant variable.

And work hard he has. Noting that he knew from as early as ninth grade that he wanted to go into accounting, Adamchick threw himself into his education, studying accounting at Hilbert College, the University at Buffalo and Canisius College before obtaining his Master's degree in finance and accounting from St. Bonaventure and an additional four-year degree in forensic accounting.

"I like that there's closure and you can finish things," he said. "You do a tax return, it's done and you move on to

the next one. I never liked positions where you're just a cog in a system and you don't really see an end product. I like the completeness.'

In addition to Adamchick's decades of experience in the industry and passion for his work, one of the major draws of the business is the affordability, which is something that Adamchick prides himself on, noting that his tax return price of \$135 is substantially lower than that of a "big-box" store like H&R.

"We're less expensive than most places. I don't think people should be overcharged when they don't have to be," he said. "If it only takes me a half hour or an hour to do somebody's taxes, I'm not going to charge them several hundred dollars iust because I can.

In addition to two of his three employees, Adamchick thoroughly reviews each return himself in a unique "system of checks and balances.

"Somebody enters it, somebody reviews it and I do the final review. It's more of a systematic approach without all of the other distractions at other places," he said. "People like to

multitask and, while I can do that, I think you get a much better product when it's gone through a review process."

In addition to individual clients, Adamchick brings the same personal, comprehensive touch to accounting, bookkeeping and record maintenance for companies.

"We do a lot of face-to-face with our business clients to make sure their books are ready for tax season," he said. "It's a lot easier for them knowing that everything's taken care of."

While tax season may be a distant thought for many right now, Adamchick emphasized that getting preemptively organized can save everyone, from residents to large businesses, the headache that comes from "the crunch of having to do a lot in a short period of time." Since most tax software systems aren't even ready until Feb. 1, the sooner you prep, the better.

"Have us see what you have before the end of the year so we can make recommendations for contributions on expenditures that will reduce vour tax burden." Adamchick said.

Even in smaller suburban areas, Adamchick explained that there isn't much com-

petition for business, which allows him to truly focus on the varying needs of each client instead of worrying about drawing them in the

"Typically, there's so many people that need the work that public accounting provides that it's not a cutthroat industry," he said. "There's plenty of work to go around."

Adamchick added that one of his favorite parts of the job has been getting to know his customers, and in the case of his recent Hamburg move, catching up with 20-or-so clients he went to high school with.

"I enjoy helping people," he said. "I give a lot of free advice out that people say, 'Oh, you should be charging for this.' But I say, 'I get paid to do your tax return; if you have questions, I'll help you

While he'll be splitting his time equally between offices, Adamchick feels he's exactly where he's supposed to be - back in his old "stomping grounds."

"I never would have imagined that I'd be looking over at my high school while I was working," he said. "It's pretty cool.
