# Colley's rebuilds, adds rental space to replace structures storm destroyed

The comeback is almost complete at Colley's Pools & Spas.

Located at 4953 Camp Road in Hamburg, Colley's took a big hit during the 2014 November snow storm, which left the company's showroom and office area shattered.

The business started in 1963 and has been at the Camp Road location since 1972. It has three locations in-state and one in Pennsylvania.

"The damage took down our showroom," said John Kerber, the field operations manager for Colley's. "It took down about 85 percent of it. We kept about 15 percent up. The roof basically inverted on itself. We lost quite a bit of product as well.

"It was quite the operation to move the snow out of the Hamburg area. People had their roofs collapsing."

Despite the devastation caused by almost 7 feet of snow that came down during the storm, Colley's continued – to this day, continues -- to serve customers.

"We operated temporarily out of trailers," Kerber said. "We converted our warehouse into our office building. We have temporary retail in our existing office area."

Nearly three years later, with the development of a retail center, aptly named, "Lake Effect Plaza," Collev's is close to establishing an even bigger presence at the

"We're going to have retail space to rent, which should enhance the Hamburg experience," said Kerber, who has been with Colley's for five years. "We'll have approximately four rental opportunities. Colley's will be anchored at one end.

Work has begun to build the new showroom, reconfigure the entrances and repave the parking areas.

According to Kerber, there will be new signage up by the road and additional green space.

should be open by spring.

"We hope to be in by March, that's our goal, to be in before the spring season," Kerber said. "Our retail space is open for our customers. Some people keep their pools open late, so we're still closing people's pools. We'll stay open throughout the process, but this is really the perfect time of year to get this done."

While the road back has been rough, Kerber has found a silver lining.

"It's been a long process, because we wanted to do it right," he said. "I'm very upbeat. I'm very excited. It's almost like a blessing in disguise. It caused us to make our business bigger and more efficient."
