Hamburg family works to make La Galleria a memorable venue

From an entirely vegan, gluten and soy-free wedding to Christmas parties booked as early as August, La Galleria banquet facility is providing guests with uniquely customizable options that reflect the family-run business' enthusiasm and creativity for the business.

With the help of a five-star ranking on WeddingWire and winning the site's Couples' Choice Award for six consecutive years, the Hamburg family running the facility has enjoyed its busiest fall wedding season on record.

The family did close its doors on Thanksgiving to celebrate together at home for the first time since opening 41

"We decided to give the staff off to enjoy the holiday. Most of them work other jobs and they still put in 500 percent this season," event manager Cherie Carducci said. "We love them, they're great."

Still, the business on 3923 Southwestern Blvd. wasn't too far from the Carduccis' minds, as the family invited several employees for dinner and started 20 hou of Christmas decorating the

"It's a huge process, but it's so much fun," event and social media coordinator Gabriella Carducci said.

Forgoing all weekends, Easters, Mother's Days and Thanksgivings in order to provide an inclusive service to clients is one of the main factors allowing the Carducci family and its 40 longtime employees to make La Galleria into a highly-recommended venue for parties, bridal and baby showers, anniversary dinners and of course, wed-

"We're responsible for people having the best day ever," Gabriella said. "We really customize each event and pour ourselves into each one - whatever you want, we'll make it happen."

In the wedding and shower realm, expansive brochures detail a variety of inclusive packages with thoughtful. anything-but-ordinary options to make the dream of every bride and groom dream come true — and on most every budget.

"We try to give everybody a great value for their money," Cherie said. "We try to be fair and I think people are pleased with that. We have a reputation for that."

Cherie added that one of her favorite parts of wedding planning is getting to develop a relationship with clients and helping them to feel comfortable and confident, and quelling any of their anxiety or confusion.

"People see sincerity in their first appointment here and any walls come down by the time the appointment is done," she said. "It's a very honest approach—we're a

part of one of the biggest events of their life, so we try to get to know them. That's really rewarding, to see them come in not knowing what to do with the process and then end up really pleased with it. It's fulfilling and it's never boring."

What also makes the venue standout is its menu, which features inventive, homecooked dishes like bacon jalapeno mac & cheese, cranberry basil chicken and stuffed veggie crepes with goat cheese and béchamel. LaGalleria offers 10 delicious add-on food stations, including a Buffalo Bar (pizza, wings and roast beef sliders) and a toast-yourown s'mores station.

Curated by Gabriella's father and Cherie's husband, Ardwin, the recipes strive to bring modern, elegant twists to down-to-earth dishes. Ingredients are hand-selected by Ardwin from area stores or from the family's own herb and vegetable garden during warmer months.

"My dad is constantly in the kitchen making new things and is like, "Here, I made this, tell me if it's good," Gabriella said. "He wants it to be the best thing possible, and we don't have a chef in the kitchen that hasn't been trained by him."

This culinary focus stems largely from the business' roots, evolving from the Carducci family home to a fine dining restaurant that specialized in Northern Italian cuisine before turning into a banquet facility in 1979. And while La Galleria is still owned by Cherie's 90-year-old mother-in-law, Aida — who still does all the laundry for the facility — it certainly

This blend of traditional and contemporary is exhibited throughout the venue and grounds in Orchard Park, bordering Hamburg, which underwent renovations five years ago to incorporate more rustic, yet elegant elements such as refurbished barn wood, white and tan brick, lanterns and the removal of the original red carpeting, which was replaced with hardwood.

"Generationally, my parents see things through different eyes, so it's nice to be able to bring a new perspective. We wanted to do something that was homey and comfortable, that people didn't feel like

they were in a big ballroom," Gabriella said. "It was like, 'Come to our house and we're going to give you the best wedding we can.'

The mother-daughter duo added that organization plays a huge role in pulling off such a celebration, with the event planning staff providing each client a final checklist a few days before to ensure that everything is properly accounted for.

"It's everything from the food you picked out to at 8:02, Grandma is walking in," Gabriella said. We're very detail-oriented."

She added, "We're onsite and so hands-on here. That's such a beautiful part of our business.'
