WHAT DOES FUTUREADVISOR DO WITH YOUR PERSONAL INFORMATION?

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons FutureAdvisor chooses to share; and whether you can limit this sharing.

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Name and email address
- Social Security number and income
- Account numbers, account balances, and payment history

When you are no longer our customer, we continue to share your information as described in this Notice.

Who we are

Who is providing this notice?

This notice applies to FutureAdvisor, Inc. ("FutureAdvisor"). FutureAdvisor is a wholly-owned subsidiary of BlackRock, Inc.

What we do

How does FutureAdvisor protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does FutureAdvisor collect my personal information?

We collect your personal information, for example, when you:

- sign up for our services
- give us your information through our website

We also may get your personal information from others, such as credit bureaus, affiliates, or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only:

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- BlackRock, Inc. and other companies with the BlackRock name are affiliates of FutureAdvisor.

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- We don't share with non-affiliates so they can market to you.

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- FutureAdvisor doesn't jointly market.
