A man of mature spiritual experience and understanding, capable of shepherding God's people and overseeing God's work. He must meet the scriptural qualifications found in 1 Timothy 3:1-7, Titus 1:5-9 and 1 Peter 5:1-4.

## **ESSENTIAL DUTIES AND RESPONSIBILITIES:**

- Shepherd all attenders and members of FBC as a servant of our Lord Jesus Christ.
- Teaching and leading attenders and members from salvation to spiritual maturity towards an ever increasing intimacy with our God.
- Lead Priesthood of Believers in regular worship service through praise, prayer and preaching of the Word.
- Edify the saints by teaching according to the Word of GOD, the Bible in order to build up the body of Christ for discipleship and to equip it to do the work of ministry and evangelism.
- Shepherd the flock by tending to their needs by visitation, encouragement, spiritual
  counseling, admonition, nurturing and administering the ordinance of believer's baptism and
  the Lord's Supper, conduct weddings, funerals, baptisms, dedications, and special worship
  services.
- Hold open meetings to all within the church for such things as corporate prayer, revival, and praise.
- As a member of the elder board, the pastor will lead, guide and oversee the matters of the church with special focus on the spiritual interests of the church.
- Subject to other constitutional responsibilities and authorities granted, or retained, by the congregation under the constitution.
- Consult with Elder Board regarding doctrinal questions that arise in the church (Acts15:4-6)
- Skilled at developing, coordinating, delegating and supporting lay ministry leaders.
- Care for the church the way a shepherd cares for his Flock (1 Peter 5:1-2)
- Keep watch over the spiritual well-being of individuals within the church (Heb.13:17).
- Share in the responsibility of all mature believers to confront and restore those who give reason to be disciplined (Gal 6:1),(1 Thess. 5:12-13)
- To write a yearly performance evaluation of all church staff members under his direction and provide the evaluation to the Elder Board for review.
- During Pastor's annual performance review, the Pastor is to provide to the Elder Board an unconditional written affirmation of FBC's Doctrinal statement.
- Recommend annual staff salary adjustment to the Elder Board for review in time for adjustment to FBC's annual budget presentation to the congregation for approval.
- Performs other duties as assigned by the Elder Board. (See FBC Constitution Sections 2.4.1, 2.4.2, and 3.3)

## **QUALIFICATIONS:**

- **Education:** Bachelor Degree of Religion or higher from an accredited school. Prefer Master's Degree of Divinity
- **Membership:** Pastor, and spouse if married, shall meet the qualifications for membership of FBC and become members.
- Experience: Must have at least seven years of pastoral experience.

- Exhibit interpersonal skills that are conducive to effective communication and that contribute to a congenial work environment. Maintain positive work atmosphere by behaving and communicating in a professional manner with Elder Board, attenders, members and staff.

- Ability to read, understand, and effectively communicate in English.
- Ability to handle biblical languages.

- 1) What Christian Theology best represents your understanding of the Bible?
- 2) How would you characterize your understanding of biblical church leadership? Do you believe in Pastor led, Elder rule, or an Elder led church and what does the selected term mean to you?
- 3) Explain the importance of prayer in our relationship with the Lord?
- 4) What is your view of corporate prayer in the life of the church?
- 5) What is the role of the senior pastor in his working relationship with the elder board and what is the role of the senior pastor as a member of the elder board?
- 6) Do you believe in limited atonement or unlimited atonement? Explain your answer.
- 7) Describe your ministry philosophy (mindset or preference), ranking in order of emphasis, or providing N/A for not applicable.

- 15) What entire books of the Bible have you taught?
- 16) Describe your ministry philosophy regarding primary roles in interacting with the congregation.
- 17) In what specific ministry areas do you expect to be personally active (e.g. Men's ministry, Sunday school teacher, small groups, counseling, Music, AWANA, VBS) and what roles would you take in these ministries?
- 18) In what ways do you personally demonstrate hospitality in your church?
- 19) What techniques do you use to be a peacemaker and to respond in a gentle manner and as a loving shepherd?
