(The theme of this film is to promote industrial development in West Germany).

Ontario Ministry of the Environment - Registrant distributes a 16mm film titled "Crisis In The Rain" to general adults and schools in the U.S. - films theme is designed to help enlist public support in the battle against acid rain in both Ontario, Canada and the U.S.

Consulate General of Israel - Registrant distributes a 16mm film titled "A Conversation With Golda Meir" - a review by the Justice Department disclosed that this film constitutes political propoganda within the meaning of Section 1(j) of the Act and must be labeled accordingly.

All the above films are labeled in compliance with Section 1(j) of the Act. Specific audience categories viewing these films are reflected on the EDP reports currently being furnished to the Justice Department monthly along with the required dissemination reports.
