Dear Francis,

On behalf of the Embassy of Saudi Arabia, I wanted to provide you with an update as to an exciting and important development for the United States and Saudi Arabia in terms of economic growth and job creation for both countries. On March 14, the Kingdom of Saudi Arabia and Boeing announced the completion of two deals worth nearly \$37 billion for Boeing to manufacture up to 121 Boeing 787 Dreamliner aircrafts equipped with General Electric's most advanced GEnx engines. These aircrafts will anchor the newly-formed [Riyadh Air](#) and expand the [Saudia Airlines](#) fleet. A fact sheet with additional details about the agreement is attached.

The deals represent a major win for American manufacturing and the U.S. aerospace industry. According to the [US Commerce Department](#), the manufacture of these aircrafts will support more than 140,000 American jobs at over 300 Boeing suppliers across 38 states. The selection of General Electric Aerospace's GEnx engine to power the aircrafts will provide "billions more in U.S. exports" and support additional "good-paying American jobs."
