The members of the Corporation are the individuals who at any given time are the members of the Executive (Committee) of the World Zionist Organization, who, in turn, are elected to their office by the Congress of the World Zionist Organization which convenes, generally in Jerusalem, every four years. The Congress of the World Zionist Organization consists of persons elected to serve as delegates at the Congress by the various Zionist organizations and Federations, which are members of the World Zionist Organization, and which are located in nearly all countries in the Free World.

In between meetings of the Congress of the World Zionist Organization, the Executive is responsible to the General Council of the World Zionist Organization, which meets approximately once a year.

The whole of the budget of the Registrant is provided by its principal, the World Zionist Organization. All decisions with respect to the budget, whether as to amounts or purposes, are determined by the Executive of the World Zionist Organization. The Registrant functions in accordance with instructions received from the Executive and within the framework of the budget allocated by the Executive for the work of the Registrant in the United States and for the purposes indicated by the Executive.

The function of the Registrant in the United States is to carry out the purposes of the World Zionist Organization as described in Exhibit A, in accordance with instructions received from the Executive of the World Zionist Organization.
