The advertising is done in major consumer, trade magazines and daily newspapers like Town and Country, New Yorker, Gourmet, Travel Weekly, Travel Trade, New York Times, Los Angeles Times, Chicago Tribune etc.

Joint Presentations are also held by Govt of India Tourist Office and Air India. Travel agents tour operators, wholesalers are invited to these presentations and are apprised of the latest tourist facilities available in India. Free literature in shape of pamphlet, brochures, posters, booklets are also distributed to travel agents, tour operators etc. A list of such presentations held in March/April 85 is enclosed.

Similarly Know India Seminars are organised at various places where again travel agents, tour operators, wholesalers and other connected with travel trade are invited and give free literature and also briefed about the tourist attractions and facilities available for tourists in India. A list of Know India Seminars held is also enclosed.

Under our Hospitality programme this office sends travel agents, travel writers, editors, television teams, photographers etc to India on familiarisation tours and they are treated as guests of the Department of Tourism, Govt of India.

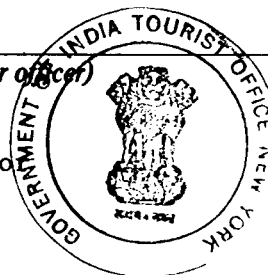
