The main function of the Govt of India Tourist Office, New York is the promotion of tourist traffic to India. This office launches an advertising campaign through an advertising agency. The advertising is in major consumer magazines as well as newspapers like New York Times, National Geographic, Natural History, Travel Trade, Travel Weekly etc.

Joint Presentations are held by the Govt of India Tourist Office and Air India. Tour operators and Travel Agents, wholesalers are invited to these presentations and they are apprised of the latest tourist facilities available in India. Free literature in shape of pamphlets, brochures posters are distributed to travel agents. A list of presentations held is enclosed.

Similarly Know India Seminars are organised at various places where travel agents, tour operators, wholesalers and other connected with travel trade are invited and briefed about India's tourist attractions.

Under our Hospitality Programme this office sends travel writers, editors, television teams, photographers, etc to India on familiarisation tours and they are treated as guests of the Department of Tourism Govt of India.

¹The term "foreign principal" includes, in addition to those defined in section 1(b) of the Act, an individual or organization any of whose activities are directly or indirectly supervised, directed, controlled, financed, or subsidized in whole or in major part by a foreign government, foreign political party, foreign organization or foreign individual. (See Rule 100(a)(9)).

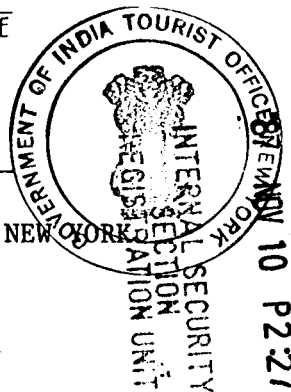
