Worked on U.S. military sales to Saudi Arabia and monitored pending trade legislation and strategic petroleum reserve developments. Responded to press inquiries on Saudi security, economic and other matters, including Saudi interest in Middle East peace settlement, Lebanese civil war, relations with other countries, and other current matters. Worked on preparations for a public exhibition "Saudi Arabia: Yesterday and Today." Traveled to California (June and September), Nebraska and Colorado (June), New York and Ohio (July), Minnesota (July, September and December), and Texas (December) for visits by Saudi officials; accompanied them but did not arrange meetings. Attended presentations by Saudi officials to U.S. government officials, press and public in Texas (June and December), and Nebraska (June), but did not arrange or take primary role in those; monitored them. In October, met with Jack Nelson of the L.A. Times and talked with Anthony Day and Jack Burby of the same paper on private Saudi investment in southern California that was subject of news coverage. Accompanied Saudi officials in June on trips to SAC Headquarters, Omaha, Nebraska, and El Toro Marine Base, Orange County, California, but did not arrange or take part in those. Talked with Washington Post's Don Oberdorfer (September), David Ottaway (September and December) and Pat Tyler (July, August,

¹The term "foreign principal" includes, in addition to those defined in section 1(b) of the Act, an individual or organization any of whose activities are directly or indirectly supervised, directed, controlled, financed, or subsidized in whole or in major part by a foreign government, foreign political party, foreign organization or foreign individual. (See Rule 100(a)(9)).

Military sales: evaluated Congressional, Executive Branch, international and U.S. public developments in discussions with Saudi officials. Accompanied latter in meetings in June with McDonald Douglas and General Dynamics officials, employees and others on Middle East developments and reasons for Saudi Arabia as to arms purchases. Registrant accompanied Saudi officials and observed rather than being a primary participant and discussant. Did not help arrange meetings.

Trade legislation: evaluated for Saudi officials, U.S. legislative, executive branch and public developments that could affect pending trade and other legislation on oil, petrochemical and related matters, particularly increased charges and potential restraints on U.S. import of those. Here, too, registrant is essentially interfacing with Saudi officials.

Responded to inquiries from State Department, Deputy Chief of Protocol on legal matter involving a dependent of Saudi Embassy staff member.

Met frequently with Embassy personnel and other Saudi officials to consider U.S.-Saudi and other developments and policy, including pending executive, legislative and administrative actions, public statements, personnel matters, political processes, court proceedings and other aspects. Monitored Congressional legislation that could importantly affect Saudi economic concerns, including possible exports to U.S., tax measures, energy proposals, arms sales and other matters.

Infrequently and on request answered business, legal and other inquiries on principal and its policies and actions, but am not a spokesman for principal nor authorized to speak on its behalf. On request, considered Saudi-U.S. developments with nongovernmental individuals who might be considered public figures in their own right.


