(A waiver of the requirement to file an Exhibit C may be obtained for good cause upon written application to the Assistant Attorney General, Criminal Division, Internal Security Section, U.S. Department of Justice, Washington, D.C. 20530.)

Attended for Saudi officials to have lunch with editor, editorial-page editor and staff members of the Boston Globe in Boston May 11. Also attended but did not arrange and only monitored meetings of Saudi officials with company management, union officials and workers at General Electric plant outside of Boston May 11 and similar group at Raytheon plant, Lexington, Massachusetts May 10; also reception in Massachusetts State Capitol for Saudi Ambassador and speech by him the same day at Harvard University's John F. Kennedy School of Government. Similarly accompanied him but did not arrange or take part in speech at World Affairs Council in Dayton, Ohio June 11 along with meetings at Wright Patterson Air Force Base outside Dayton, and World Affairs Council in Los Angeles June 12. Accompanied Saudi Ambassador for meeting with Los Angeles Mayor Tom Bradley June 12, but only monitored this meeting. Accompanied him also for meetings with local citizens and officials in Aspen, Colorado March 1-5 and June 8-10 but did not arrange and only monitored.

Hosted dinner at home, for Saudi Ambassador March 16 to talk with Tom Friedman, New York Times; Terrance Smith, CBS; Norman Kempster, Los Angeles Times; Ray Moseley, Chicago Tribune; Pat Tyler, Washington Post; Joan Mowrer, Associated Press; and Susie Elfing, Administrative Assistant to Senator Barbara Mikulski, on developments in Saudi Arabia and the Middle East. Accompanied Ambassador to luncheon with editors and staff of U.S. News & World Report January 30, but only monitored session. Talked with Washington Post's Don Oberdorfer, David Ottaway and Pat Tyler on Saudi matters at their initiative and by telephone, on several occasions in January, April and May; Youseff Ibrahim of the New York Times twice by telephone at his initiative in April; and Geraldine Brooks of the Wall Street Journal twice in January at her initiative; and Washington Post's Caryle Murphy at her initiative. Responded to a number of phone calls from CBS 60 Minutes program staff in January, February and March, including Harry Reasoner and George Crile, on Saudi questions.

Responded to inquiries from State Department Near East Bureau officials initiated by them on pending legal matters involving Saudi personnel; also with U.S. Customs officials in Washington and Florida on Saudi national in U.S.

Met frequently with Embassy personnel and other Saudi officials to consider U.S.-Saudi and other developments and policy, including pending executive, legislative and administrative actions, public statements, personnel matters, political processes, court proceedings and other aspects. Monitored Congressional legislation that could importantly affect Saudi economic concerns, including possible exports to U.S., tax measures, energy proposals, arms sales and other matters.

Infrequently and on request answered business, legal and other inquiries on principal and its policies and actions, but am not a spokesman for principal nor authorized to speak on its behalf. On request, considered Saudi-U.S. developments with nongovernmental individuals who might be considered public figures in their own right.
