

Korea: Nori Madang Performances

Seoul's Nori Madang, traditional outdoor theater, will make its spring premier with weekend performances at Sokchonhosu Lake, Chamshil district. The Saturday and Sunday performances are scheduled for 2 pm - 4 pm in April and there is no admission fee.

"Nori Madang is an excellent opportunity for travelers to experience Korea's culture. Madang is an outdoor theater and it is similar to theater in the round," Duk-Soo Hur, Director of Korea National Tourism Corp. in Los Angeles, said.

The Mask Dance is one cultural highlight. The Mask Dance, which originated in the Hahoe Region, is a combination drama and vocal concert. Each performer's role is reinforced by an ornately carved mask.

Seoul Nori Madang is located near Sokchonhosu Lake, at Lotte World in the Chamshil district. The performance schedule is 2 pm - 4 pm in April and October; 3 pm - 5 pm in May and September; and 5 pm - 7 pm in June, July and August.

Seoul: City of Kings

Seoul (its name means "capital") has been the capital of Korea since the beginning years of the Choson Dynasty and 1994 will be Visit Korea Year in honor of the city's 600th anniversary as Korea's capital.

The Choson Dynasty thrived from 1392 to 1910 and Seoul became the Choson capital in 1394. As a modern "city of kings", Seoul will celebrate its anniversary with parades, fireworks and special festivals. Modern Seoul is an oasis of culture, hospitality and good shopping for international travelers.

Seoul combines an ancient culture with a modern spirit. The South and East gates, historic entrances to Seoul, are traffic hubs. The South Gate and East Gate markets are picturesque shopping adventures. Koreans shop at the South Gate Market for inexpensive clothing and groceries. The East Gate Market is Seoul's silk center and many stalls specialize in household goods.

In contrast to the hectic tempo at the open-air markets, the Choson-era palaces are tranquil interludes in Seoul, the world's fifth largest city.

Kyongbok Palace, the first of five Choson palaces, is a complex of grand buildings and parks. Kyonghoeru Pavilion served as an open-aired reception hall and Hyangwonjong was a tea pavilion.

Changdok Palace is the garden palace and there are hourly tours in Korean, English and other foreign languages. The gardens, covering 78 acres, were originally reserved for royalty. There are secluded pathways, lotus ponds and impressive buildings.

Toksu Palace, in downtown, is surrounded by 20th century skyscrapers. It is the smallest of Seoul's palaces, but its tile roofs and traditional buildings are an interesting photographic contrast to modern highrises. The three palaces are open daily and admission is less than \$3.

Seoul is an exciting shopping destination. Itaewon, a popular district for international shoppers, is home to more than 100 tailor and clothing shops. Silk blouses cost about \$25 and tailored suits start at about \$150.

Shopping in another country means discovering new items, such as eelskin and celadon. Soft and sturdy eelskin is used for shoes, purses, wallets, briefcases, belts, bracelets and necklaces. Prices are about 50 percent less than in the United States and the variety is endless.

Insadong is Seoul's art and reproduced-antique district. Insadong is a treasure trove for celadon, calligraphy and Choson-style chests.

Celadon styles reflect Korea's history. Choson-style celadon is a creamy white color. Koryo-style celadon, the most famous, is a delicate shade of teal or "kingfisher blue". The vases have a white motif of cranes for longevity or dragons for good luck. Shilla-style celadon uses dark colors: brown, red and black.

Insadong shops stock celadon and reproduced Choson chests. The antique-style chests, in all shapes and sizes, are ideal conversation pieces. A combination make-up and jewelry box includes a stand-up mirror.

Seoul is an around-the-clock destination. A morning city tour features the ancient palaces. An afternoon shopping agenda can include Itaewon and Insadong. Seoul becomes a cultural destination in the evening.

The Korea House is a combination restaurant and theater. A traditional Korean banquet is served buffet style. After dinner, there is a traditional dance program in the Korea House theater.

The Fan Dance is a kaleidoscope of color. The dancers, dressed in the formal hanbok, form geometric patterns with their fans. Dancers demonstrate their flexibility in the Drum Dance. The drum beats are incorporated into the dance. The Farmer's Dance is a dance of appreciation for a bountiful harvest. The dancers are almost acrobatic and their goal is making their dance-cap ribbon swirl like a lasso.

Seoul is Korea's primary gateway for international travelers and it is a city with an intriguing combination of an ancient culture and modern spirit.
