The Korea Trade Center, Los Angeles, is an overseas branch office of the Korea Trade Promotion Corporation, which is a non-profit government agency charged with advancing two way trade between the United States and the Republic of Korea.

In keeping with our overall duties as defined above, during the reporting period we undertook the following activities:

1. Provided information to Korean businessmen about the buyers and sellers in the United States.
2. Provided American businessmen with information on buyers and sellers in Korea. In other words, we answered the questions of interested American importers who either visited, called or wrote to our office. To these interested importers we sent catalogs on various Korean products and the names of companies who produced them.
3. Answered inquiries on general procedures for conducting business with Korea, to all making inquiry to our office, either in writing or by telephone.
4. Arranged meetings for visiting Korean businessmen to meet local American businessmen interested in developing business transactions with Korea. In other words, we assisted various Korean businessmen who visited Los Angeles, as well as arranging the itinerary for American businessmen traveling to Korea. All help was of a marketing orientation. To those Koreans visiting our office, we introduced them to American importers, and provided them with buyers lists and market research material.
5. Prepared research and economic update reports for the head office in Korea. Many of these reports included topics on the economic situation of the United States, more particularly of the Western Coast region, and the relation between such information and its effect on international trade. Other reports included current marketing information about the Korea's major export items, such as; VCRs, Eel skin, Wheel chairs, Electronic components, Tape measures, Hair dryers, Binoculars, Fluorescent lamps.
6. Located American manufacturers of current needed items required Korea in its effort to diversify sources of materials from Japan to America. This function of our office became more Valuable, as the American dollar has dropped in value making imports of American products more attractive in Korea, as well as helping to reduce tensions with America over the current trade imbalance.
