For the Foreign Ministry of the Royal Kingdom of Saudi Arabia, the Registrant has not engaged during the six-month period in any activities for, or rendered any services to, the foreign principal, other than keeping abreast of developments and the occasional furnishing of information.

For the Shipping Corporation of India, Ltd. (SCI), the Registrant has conducted activities in support of an exemption from the controlled carrier provisions of the Shipping Act of 1978 for non-communist developing countries, namely § 9(f) of H.R. 4374. These activities include analysis, conversations, correspondence, and meetings with SCI and the Embassy of India, as well as U.S. Government officials, relating to the exemption.

<sup>1</sup>The term "foreign principal" includes, in addition to those defined in section 1(b) of the Act, an individual or organization any of whose activities are directly or indirectly supervised, directed, controlled, financed, or subsidized in whole or in major part by a foreign government, foreign political party, foreign organization or foreign individual. These activities consisted of meetings with Mr. Edmund B. Welch, Chief Counsel of the House Committee on Merchant Marine and Fisheries, on April 30; Mr. John L. Long, Counsel to that Committee, on April 30; Mr. Stephen D. Little, Minority Counsel to that Committee, on April 26 and 30; and Hon. Mario Biaggi, Chairman of that Committee, on April 7. In these meetings, support for § 9(f) of H.R. 4374 was expressed.

The Registrant has not arranged, sponsored, or delivered speeches, lectures, or radio and TV broadcasts on behalf of The Shipping Corporation of India, Ltd.
