Registrant has contracted with the Ministry of Foreign Affairs to provide assistance in the design of programs and materials to inform the American business community about Saudi Arabia and to encourage bilateral trade; to broaden the participation of the Kingdom in Arab-American organizations; and to serve as a contact for the Government of the Kingdom of Saudi Arabia with members of the media. Registrant is also required to report on a regular basis to H.E. the Ambassador of the Kingdom of Saudi Arabia.

Shortly before the end of the reporting period, Registrant entered into a contract with the Foreign Liaison Bureau for the production of certain films. However, only preliminary planning was done during the reporting period.
