11. Registrant has been under contract with the Ministry of Foreign Affairs to provide assistance in the design of programs and materials to inform the American public about Saudi Arabia and to encourage bilateral trade; to broaden the participation of the Kingdom in Arab-American organizations; and to serve as a contact of the Government of the Kingdom of Saudi Arabia with representatives of the media. Registrant was also required to report periodically to H. E. the Ambassador of the Kingdom of Saudi Arabia. Registrant also served as a consultant to responsible Saudi representatives with regard to the U.S. political process.

During the six-month reporting period, Registrant's "political activity" as defined in the Act was minimal. Registrant's duties consisted almost entirely of serving as a consultant to the Foreign Principal.
