NORTH AMERICAN OFFICE YEAR-TO-DATE (Y-T-D) EXPENDITURES



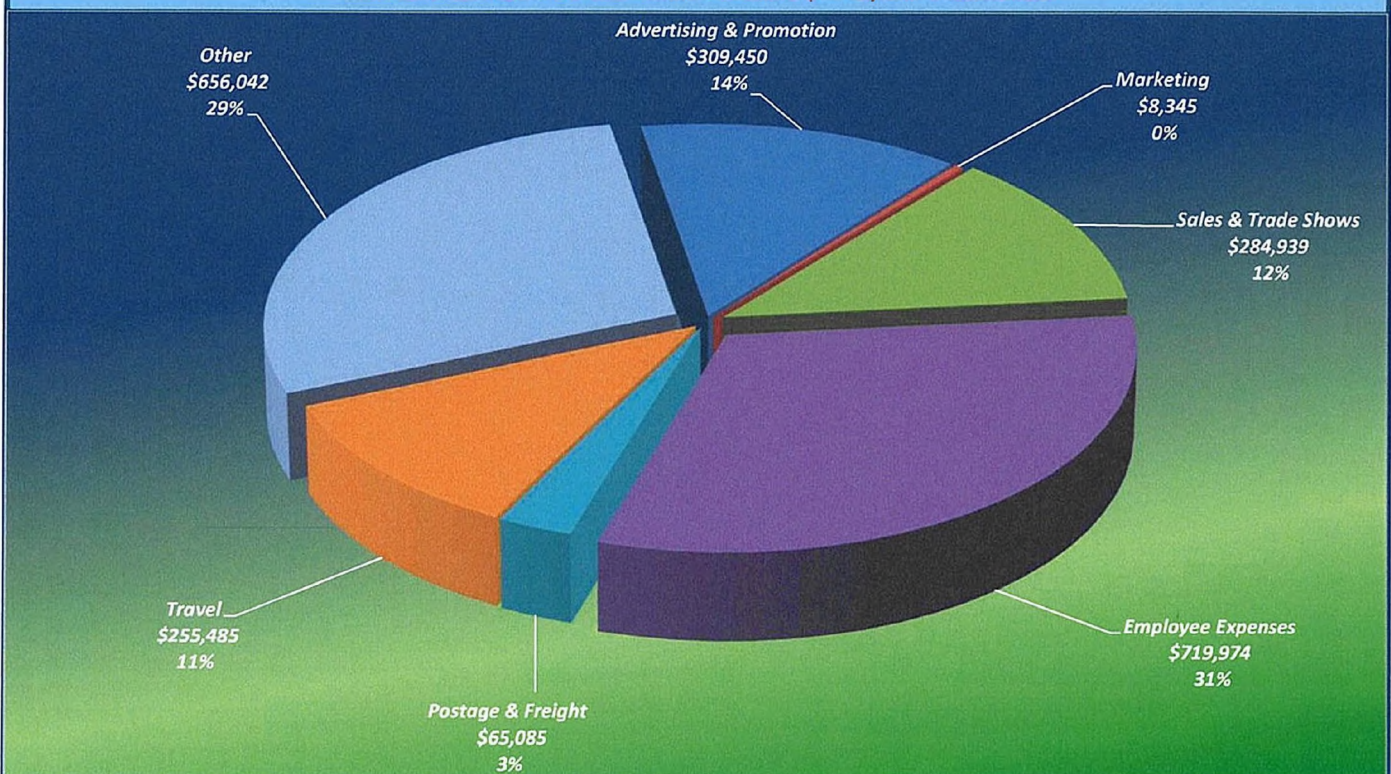
