Deutsche Lufthansa AG hereby places an Order, the value of which is \$ 37,660.00, for services to be performed by the partner specified under Par. 9 of this agreement in accordance with the attached Order No. \_\_\_\_\_ dated \_\_\_\_\_ and subject to the General Conditions of Purchase and Supplies to LH.
2. The partner agrees to accept the total equivalent of the above Order/ 100 % % of the total equivalent of the above Order in the amount of \$ 37,660.00 in form of passenger tickets and/ or air freight from Deutsche Lufthansa AG,  
 Status: confirmed /Class: open /Air freight transportation
