The Government of Bolivia

The registrant has represented the Government of Bolivia before Congress and various Executive Branch departments and agencies. It has also rendered advice to Bolivia on specific projects of interest to Bolivia involving the major lenders in the United States and potential investors from the American private sector. The law firm also provided legal advice to the Government of Bolivia on various tax matters, banking issues, and potential litigation. The law firm also represented the Central Bank of Bolivia in connection with negotiations aimed at reducing or eliminating Bolivia's commercial debt.

Gregory Mevs

During this reporting period, the registrant represented Mr. Mevs before various Executive Branch departments and agencies and advised Mr. Mevs about procedures for applying for and obtaining a license from the Office of Foreign Asset Control. The registrant also advised Mr. Mevs about developments affecting U.S.-Haiti relations and Haiti's return to democracy.
