The registrant continues to represent the Government of Bolivia before Congress and various Executive Branch departments and agencies as requested and instructed by the Ambassador. The registrant's activities have been sharply curtailed, however, and the extent of those activities appears in Attachment II.

Gregory Mevs

During this reporting period, the registrant represented Mr. Mevs and the members of the Mevs family before various Executive Branch departments, primarily the Department of State and the National Security Council, and in connection with the congressional activities relating to the crisis in Haiti. The registrant continued to advise Mr. Mevs and the members of his family as to ways that they can best contribute -- in the United States as well as in Haiti -- to a resolution of the crisis and a restoration of democracy in that country.
