The foreign principal was the Ministry of Commerce and Industrial Development of Mexico (SECOFI). We contacted Members of Congress and staff to discuss various issues relating to the North American Free Trade Agreement (NAFTA) as well as GATT issues. We advised the foreign principal with regard to its activities with individuals in the U.S. public and private sector relating to NAFTA as well as advising on various GATT issues.

¹The term "foreign principal" includes, in addition to those defined in section 1(b) of the Act, an individual or organization any of whose activities are directly or indirectly supervised, directed, controlled, financed, or subsidized in whole or in major part by a foreign government, foreign political party, foreign organization or foreign individual. 


