

I am an employee of TransCanada PipeLines. My main responsibility is to monitor developments relating to energy regulation, energy markets, and the company's interests and activities in the United States (which are regulated by the Department of Energy and the Federal Energy Regulatory Commission). During the reporting period, I had contact at various times with officials of the U.S. Department of State, U.S. Department of Energy, U.S. Department of Commerce, and legislative staffers.

In addition, TransCanada is a member of the Interstate Natural Gas Association of America. I attended various committee meetings of this trade group.

With the exception of the contacts noted below (in item 12), all of these contacts were non-political and non-registrable in nature and included requests for the status of regulatory proceedings or other government agency actions, technical (non-merit) questions about regulatory issues, and discussions of company activities that did not extend to policy issues.
