We disburse ongoing updates about Sweden as tourist destination via visitsweden.com, Facebook, Twitter and Instagram.

We offer travel information on www.goscandinavia.com in cooperation with other Scandinavian tourist boards. We also conducted an event “Scandinavian Workshop” in Los Angeles together with the other Scandinavian tourist boards where we invited local Tour Operators to meet with Scandinavian partners for networking and create business opportunities.

We’ve conducted web campaigns for West Sweden, Swedish Lapland and Stockholm on Expedia.com, Facebook, Instagram, Tripadvisor, Travelocity and Xaxis.

We ran separate online-based promotion campaigns for western, eastern and northern Sweden.

We conducted an event in New York together with SACC-NY “From farm to fork” where West Sweden where the region in focus.

We help tour operators and agents to obtain information on tourist attractions, cultural events, historical sights, hotels and more.

We assist press trips to Sweden to support journalists with information about Sweden and relevant connections in the destinations they will be visiting. During the stated period we assisted individual press trips to Stockholm and West Sweden/Gothenburg.

We facilitated a familiarization tour for Meeting & Incentive agents, travel agents and tour operators where they visited Stockholm and Swedish Lapland to better sell the destination to their clients.

We have been on roadshows in Canada and central USA to meet preferred travel agents with US as a market with the purpose to present Stockholm as a destination to increase knowledge about what to do, where to stay and how to best get there.

We participated in Travel Agent and Tour Operator Networking conferences such as Virtuoso Sales Meeting, Signature Sales Meeting and USTOA Travel Week.
