

11. I have worked with the Embassy of Lithuania over the last six months and my activities are designed to promote a greater understanding of issues in Lithuania and to advance Lithuania's already existing good relations with the United States. I have met with US government officials including Members of Congress and their staffs on current issues of bilateral importance. Details regarding these meetings are listed in the response to question 12.

12. On behalf of the Ambassador of Lithuania to the United States I have arranged meetings between Embassy staff and Congressional staff members. I have personally met and telephoned Congressional staff on a regular basis to provide an update on the status of already existing strong ties with the United States. Our discussions refer to legislation, Congressional statements and letters of support and Administration actions. In particular, activities related to the promotion of increased US-Lithuanian military cooperation and the enlargement of NATO.
