This amends the Supplemental Statement for the period ending January 31, 2018 to more fully respond to Items 11 and 14. For Item 11, SPII, on behalf of the Kingdom of Saudi Arabia and the Saudi Arabian Oil Company, gave \$118,000 to the Permanent Mission of the Kingdom of Saudi Arabia to the United Nations to help pay for a Saudi National Day reception held at the UN in New York. This money paid for hiring a band to perform at the September 27, 2017, event and a photographer to photograph it. For Item 14, the money spent by SPII on September 27, 2017 on behalf of the Kingdom of Saudi Arabia and the Saudi Arabian Oil Company for the Saudi National Day reception at the United Nations were reimbursed by the Saudi Arabian Oil Company.
