To that end, Jones Walker has worked to bridge the gap in information in the United States Congress about Turkey, combat anti-Turkish lobbying with proactive activities, create a better environment for positive engagement by working to establish a dialogue between the Ambassador and members of Congress and their staff, and work on specific issues as they arise to the betterment of Turkey's position.


