ORION STRATEGIES LLC

SERVICES AGREEMENT

This is an agreement under which Orion Strategies LLC, 918 Pennsylvania Avenue SE, Washington, D.C., 20003, agrees to perform services on behalf of the Government of Romania.

EFFECTIVE DATE/TERM

The effective date of this agreement is November 21, 2001. The term of this agreement is 12 months, ending November 21, 2002. This agreement may be extended upon agreement by both parties.

SCOPE

For the term of this contract, under the direction of the Minister of Foreign Affairs, the Ambassador of Romania to the United States, and/or their designee (s), Orion Strategies LLC will provide advice and consulting services concerning Romania's candidacy for membership in the North Atlantic Treaty Organization (NATO).

Services pursuant to this agreement will include, but not be limited to, advice, guidance, and support for strategic communications, public relations, advocacy and related activities in the United States to assist Romania's efforts to achieve their objectives in meeting NATO membership criteria and communicating developments in Romania to U.S. decision makers.

REPORTS

Orion Strategies LLC will provide the representatives of the Ministry of Foreign Affairs of Romania with a monthly progress report on Romania's objective to join NATO. The focus of this report will be tailored to specific needs and interests.

TEAM MEMBERS

The project manager for Orion Strategies LLC will be Randy Scheunemann. Team members will include Mike Mitchell and Beth Karaica.

COMPENSATION

During the term of this agreement, Orion Strategies LLC will be compensated at the rate of \$10,000 per month. Directly related out of pocket expenses such as taxis, FedEx, meals, etc. will be fully reimbursed at cost and based on a mutually agreeable level.

Orion Strategies LLC will provide expense information that includes the necessary level of detail. Any out of area travel expenses will be reimbursed only if approved in advance.

PAYMENT

Orion Strategies LLC will be paid in U.S. dollars by Romania through the Embassy of Romania in the United States located at 1607 23rd Street, NW, Washington, DC 20008.

Payment will be rendered in quarterly installments of \$30,000 due by November 21, 2001, February 21, 2002, May 21, 2002, and August 21, 2002. Approved expenses will be reimbursed the quarter after they are incurred, except for approved out of area travel which will be reimbursed within 30 days of being incurred.

CONFIDENTIALITY


Orion Strategies LLC agrees to take every reasonable step to prevent disclosure of any and all confidential information provided to it by Romania to third parties. Confidentiality shall extend to all information deemed confidential by Romania whether provided by or on behalf of Romania or developed by Orion Strategies LLC on its behalf.

TERMINATION

Termination of this agreement shall require thirty days written notice by either party.
