

LIMITED LIABILITY COMPANY**

Pursuant to Chapter 12 of Title 13.1 of the Code of Virginia the undersigned states as follows:

1. The name of the limited liability company is: Livingston/Moffett Global Consultants, L.L.C.
2. The limited liability company is organized to engage in any lawful activity for which limited liability companies may be formed.
