**Privacy Act Statement.** The filing of this document is required for the Foreign Agents Registration Act of 1938, as amended, 22 U.S.C. § 611 *et seq.*, for the purposes of registration under the Act and public disclosure. Provision of the information requested is mandatory, and failure to provide the information is subject to the penalty and enforcement provisions established in Section 8 of the Act. Every registration statement, short form registration statement, supplemental statement, exhibit, amendment, copy of informational materials or other document or information filed with the Attorney General under this Act is a public record open to public examination, inspection and copying during the posted business hours of the Registration Unit in Washington, DC. Footnote: "Political activity," as defined in Section 1(o) of the Act, means any activity which the person engaging in believes will, or that the person intends to, in any way influence any agency or official of the Government of the United States or any section of the public within the United States with reference to formulating, adopting, or changing the domestic or foreign policies of the United States or with reference to the political or public interests, policies, or relations of a government of a foreign country or a foreign political party.

#### **Section 11**

Registrant will provide public relations counsel to the Abu Dhabi Investment Authority regarding communications and media strategy targeted to the general public of the United States. Registrant will provide advice and support to the Abu Dhabi Investment Authority relating to their communications efforts directed toward executive and legislative branch officials of the US Government.

Registrant will provide public diplomacy, strategic communications counsel and government relations services for the Government of Egypt. Registrant's activities will include communications associated with the Government's implementation of its Road Map to build the institutions of an inclusive democratic state through parliamentary and presidential elections. The terms of the agreement and scope of work have not yet been determined. A copy of the agreement will be filed as an Amendment to Exhibit B upon execution.

Registrant will act as an advisor to LN Communication on communications and government affairs matters pertaining to the Democratic Republic of the Congo's commercial relations with U.S. political, business and financial communities.

Registrant will provide communications and government relations counsel and support to the Government of Saudi Arabia in connection with general foreign policy and related matters, as well as legislative, public policy and media-related activities of interest. As requested, registrant will undertake specific advocacy assignments with regard to legislative, public policy or public affairs matters.

#### **Section 12**

Registrant will provide public relations counsel to the Abu Dhabi Investment Authority regarding communications and media strategy targeted to the general public of the United States. Registrant will provide advice and support to the Abu Dhabi Investment Authority relating to their communications efforts directed toward executive and legislative branch officials of the US Government.

Registrant will provide support for the Government of Egypt's communications with U.S. government officials, business community, non-governmental audiences and the media; and fostering and facilitating exchanges between the U.S. and Egypt.

Registrant will act as an advisor to LN Communication on communications and government affairs matters pertaining to the Democratic Republic of the Congo's commercial relations with U.S. political, business and financial communities.

Registrant's activities may include specific advocacy assignments with regard to U.S. Government officials, Members of Congress and their staffs, representatives of media organizations and/or other individuals involved in legislative, public policy or public affairs matters, and/or in other activities of interest to the Government of Saudi Arabia, including the Middle East regional security, counter-terrorism, and related issues.
