

AMENDMENT NO. 6 TO CONSULTING SERVICES AGREEMENT

This AMENDMENT NO. 6 TO CONSULTING SERVICES AGREEMENT is made and entered into as of April 1, 2026, to amend that certain Consulting Services Agreement dated November 18, 2024, and subsequent amendments dated January 1, 2025, April 1, 2025, July 1, 2025, October 1, 2025, and January 1, 2026 (collectively, the "Agreement") by and between **Mercury Public Affairs, LLC** ("Consultant") and **Embassy of the Republic of Korea in the USA** ("Client").

AMENDED TERMS OF AGREEMENT

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Consultant and the Client agree as follows:

1. Term. The Term of the Agreement is hereby amended and extended effective as of April 1, 2026, and will continue through June 30, 2026.
2. Compensation and Expenses. The compensation is amended, and Client agrees to pay Consultant \$20,000 per month for the Term beginning April 1, 2026, invoiced monthly during the Term, to be paid within thirty (30) days of invoice.

Consultant will not perform Services and this Agreement is not effective until Agreement is duly signed and executed by Client and delivered to Consultant. Any filing fees for registration with FARA Registration unit are, if any, considered to be included in the compensation above. Considerable business expenses will only be incurred with the prior consent of the Client. All other miscellaneous business expenses associated with providing the services are also considered to be included in the compensation above.

3. Agreement Confirmed. The Agreement and its terms are confirmed. Except as specifically amended herein, no other amendments or modifications are intended or made.
