Embassy of Japan - The registrant monitored federal, state, and local political news in Virginia of possible interest to the principal and monitored legislation and commending resolutions introduced during the 2019 session of the Virginia General Assembly. The registrant corresponded with the office of the Governor of Virginia to postpone an event the Embassy of Japan intended to host in March 2019.

Consulate-General of Japan in Atlanta - The registrant has been monitoring state and local legislative and policy developments of possible interest to the principal. The registrant engaged in nonpolitical activities by providing event planning services for a special event held by the principal.
