 - Turkey has been a crucial ally in the War on Terror.

 - The EU launched its biggest humanitarian aid project ever supporting almost 1 million Syrian refugees in Turkey by giving them a prepaid card, which will be systematically monitored.
 - As 90% of Syrian refugees in Turkey do not live in refugee camps, the prepaid cards allow refugees to pay for food and electricity.
