- Bozdag's said "We offer our condolences to the families of the deceased in the attack targeting participants of a music festival in Las Vegas, to the American people and to the U.S. We condemn this horrible, abominable attack. We share the pain of the families of the American people".

 - The EU launched its biggest humanitarian aid project ever supporting almost 1 million Syrian refugees in Turkey by giving them a prepaid card, which will be systematically monitored.
 - As 90% of Syrian refugees in Turkey do not live in refugee camps, the prepaid cards allow refugees to pay for food and electricity.
