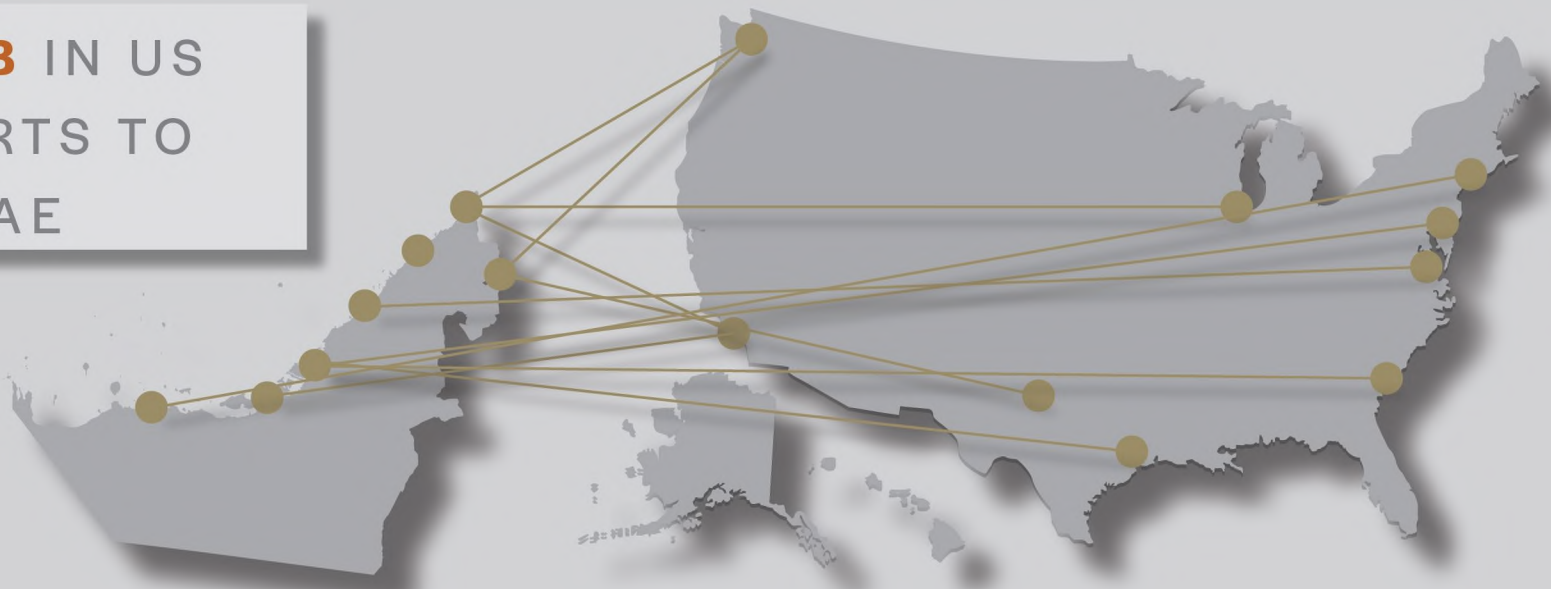

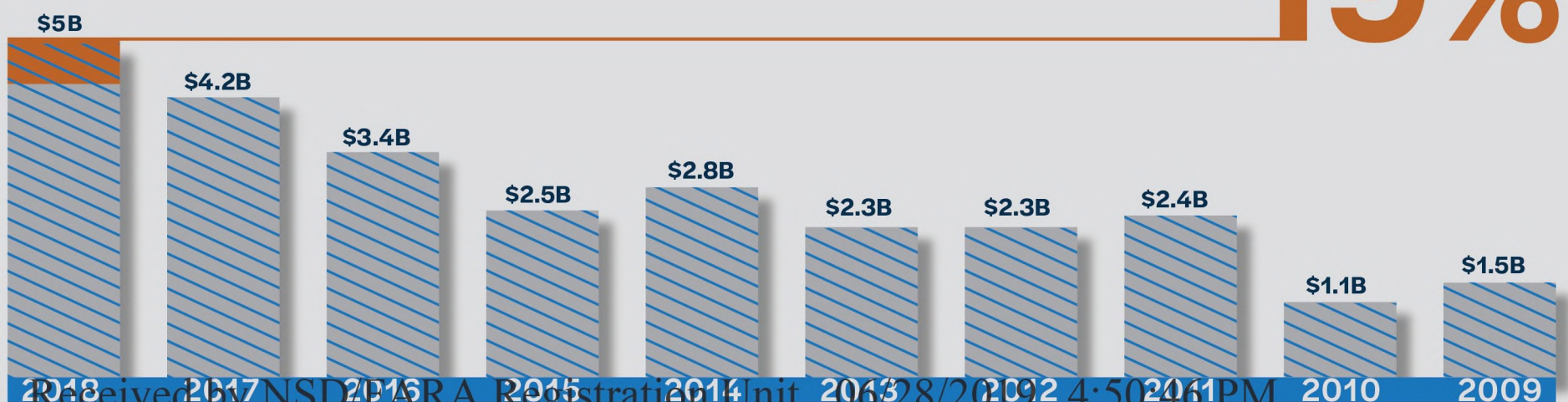

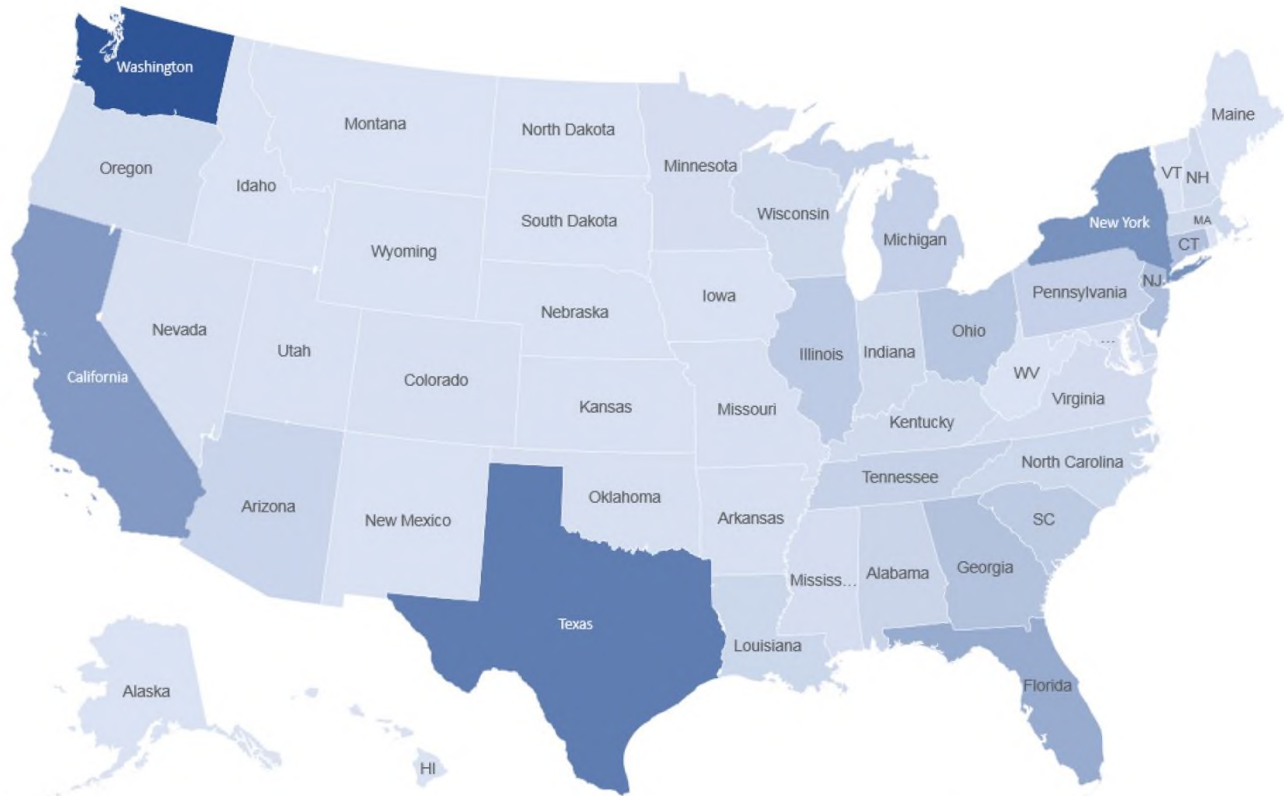

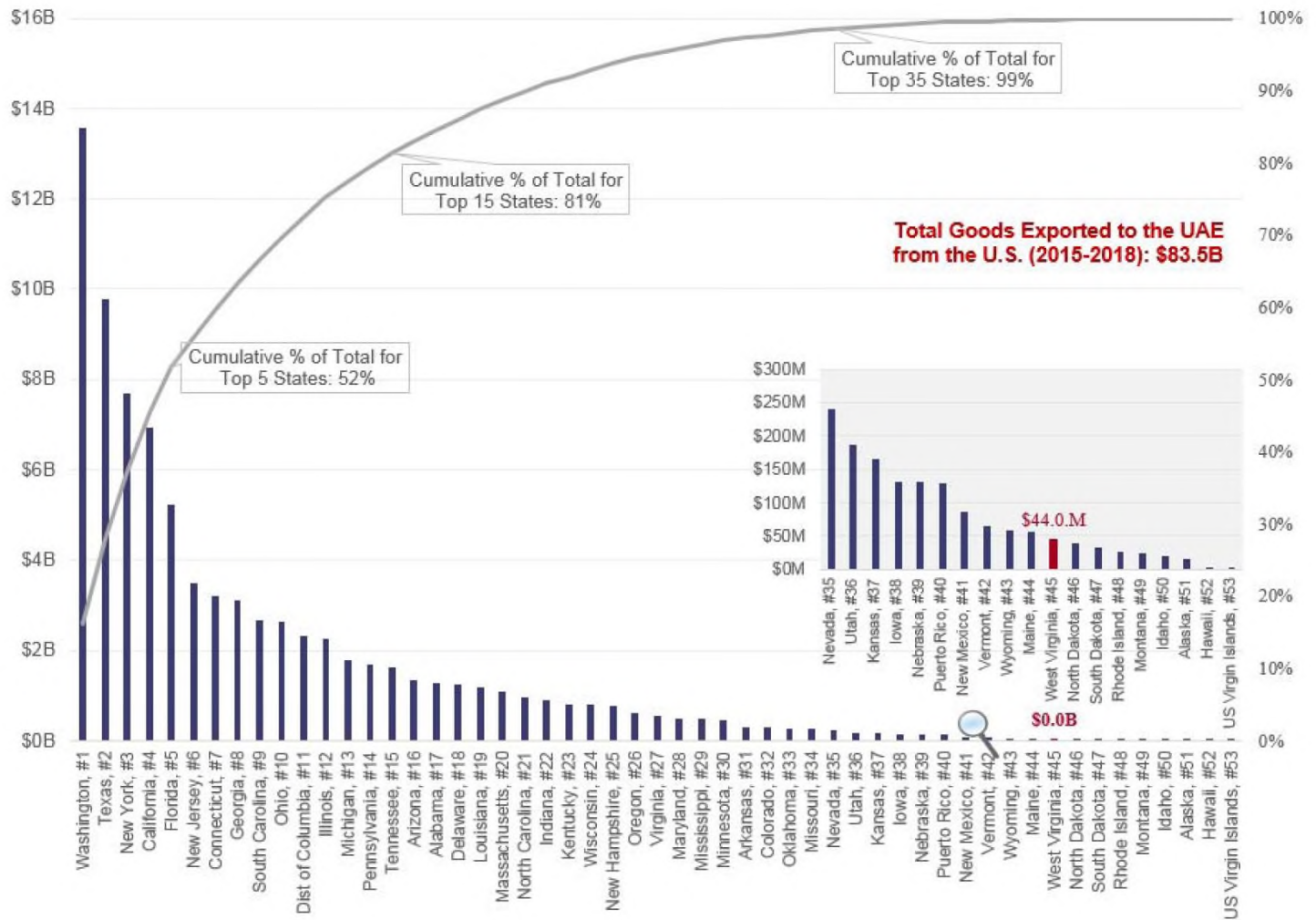

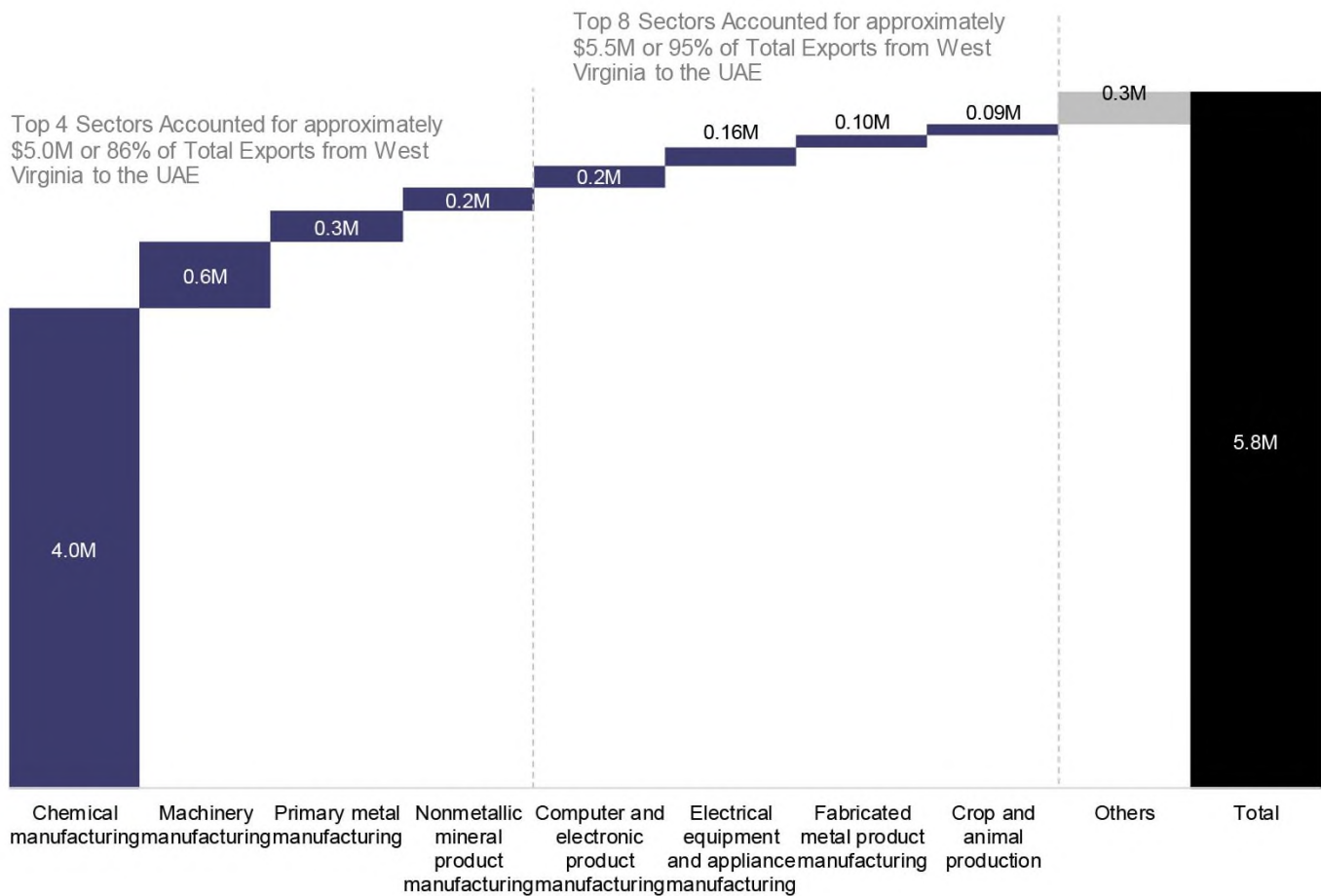


West Virginia Exports to the UAE

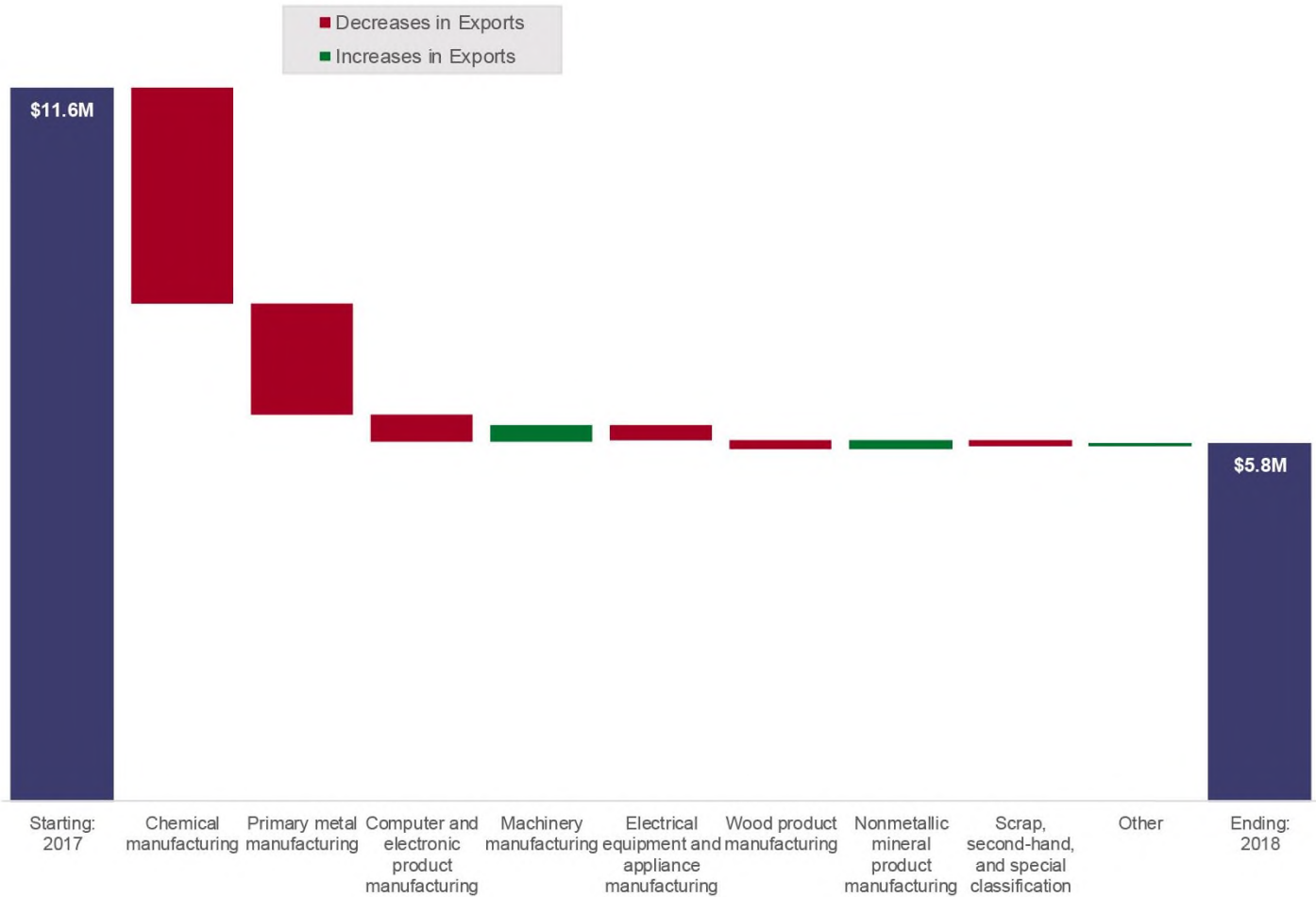

Exhibit I.4 | West Virginia's Exporting Sector Movements From 2017 to 2018

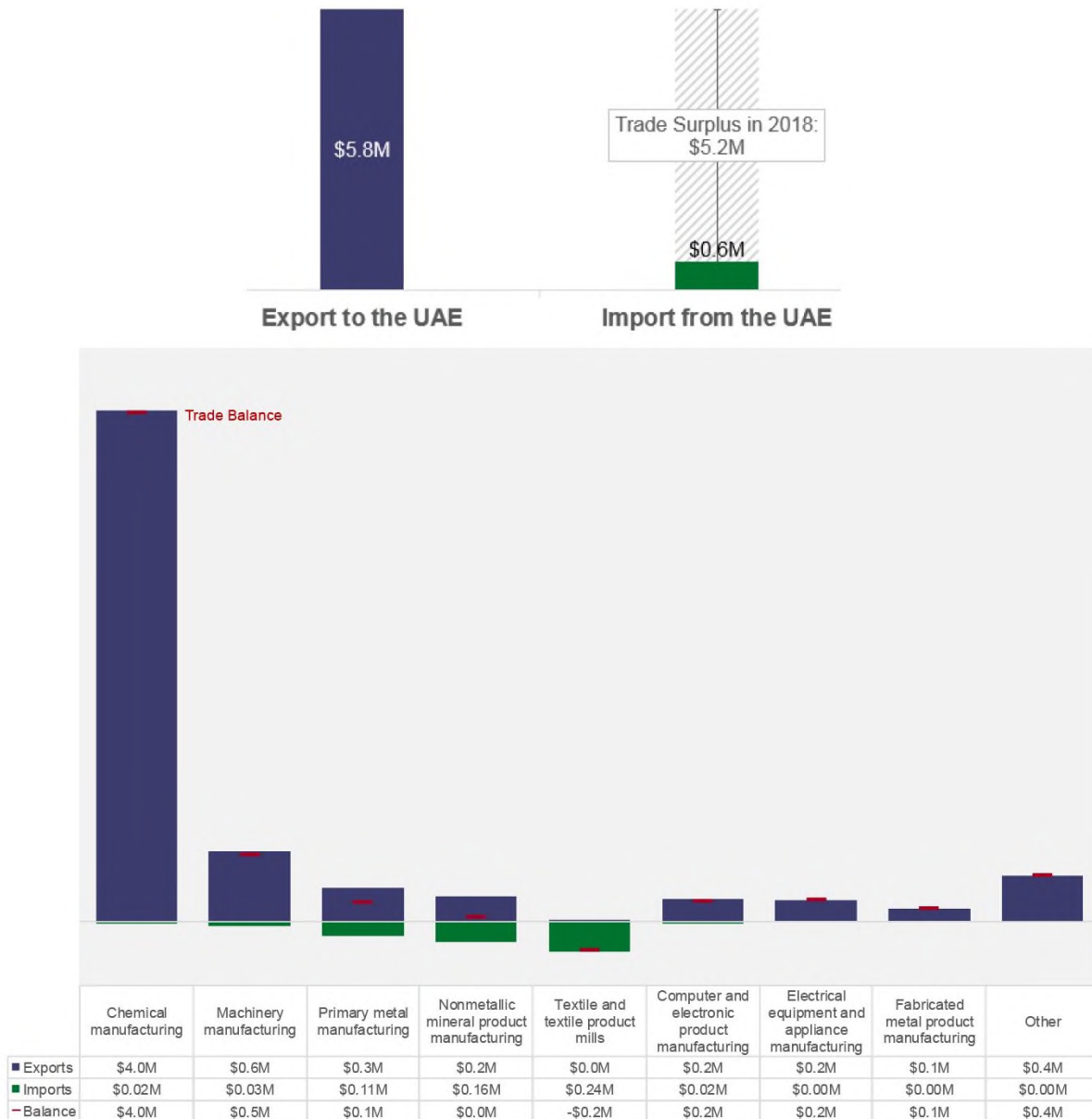

Exhibit I.5 | West Virginia's Trade Surplus with the UAE by Sector

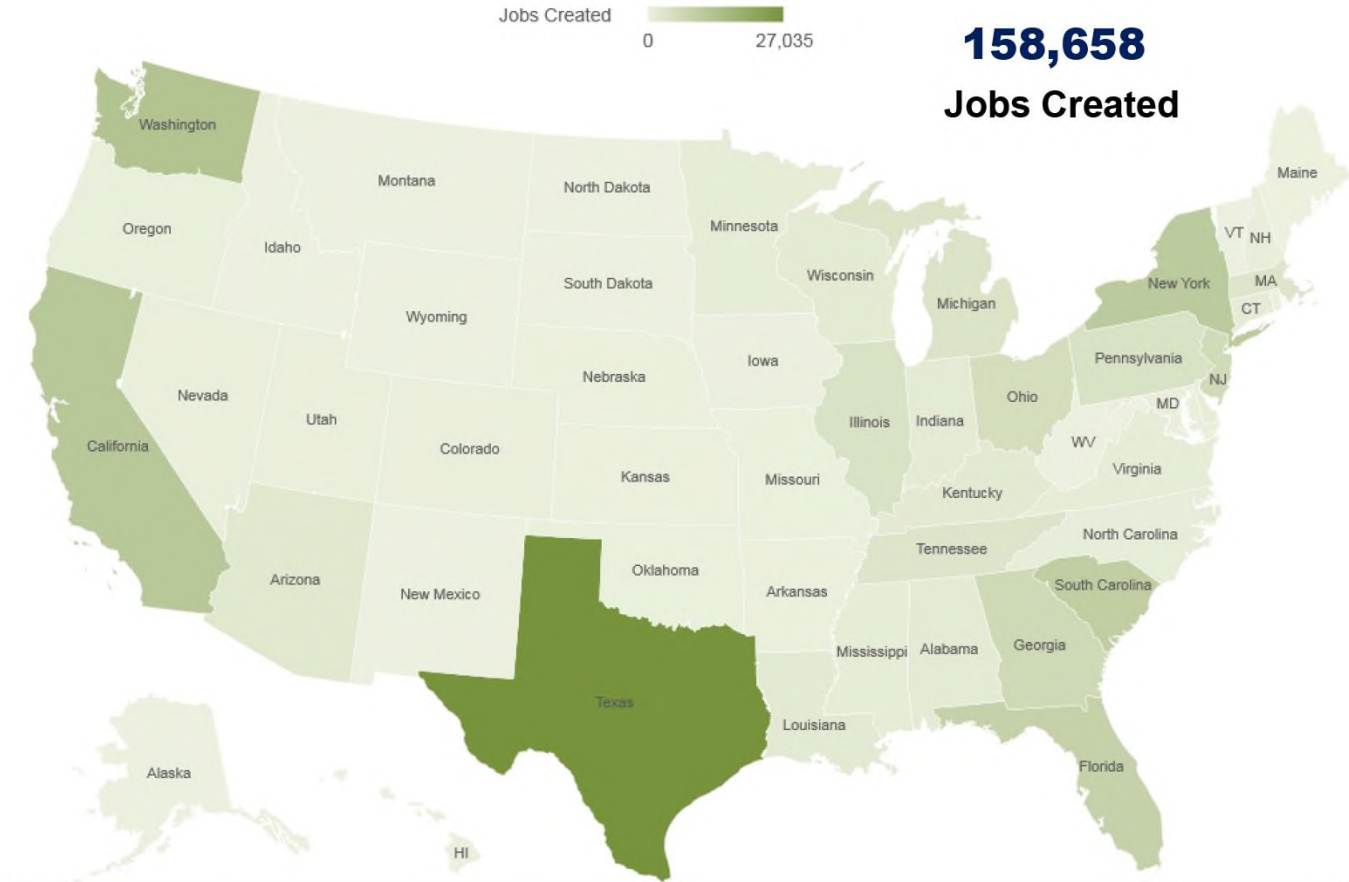

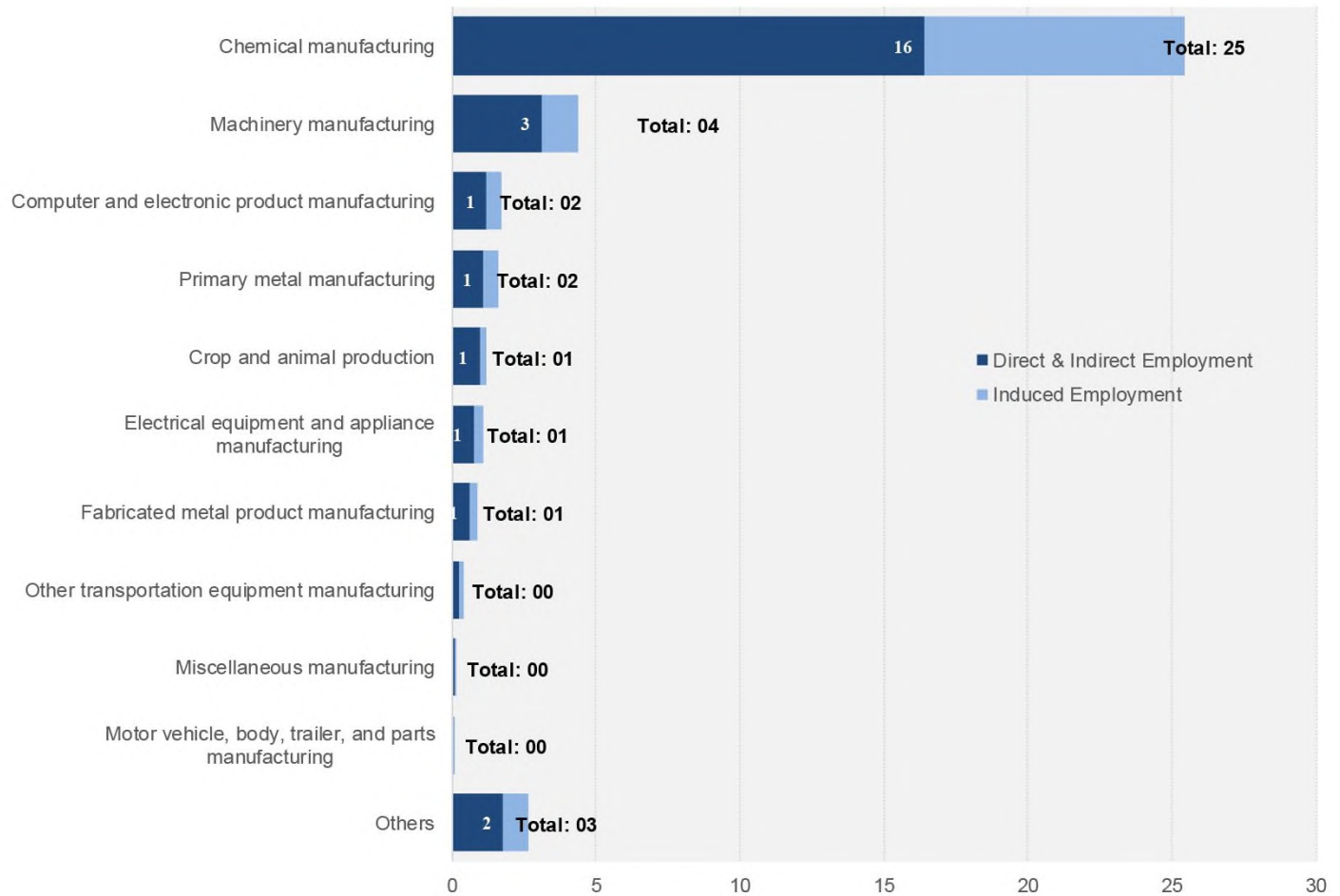

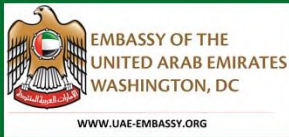

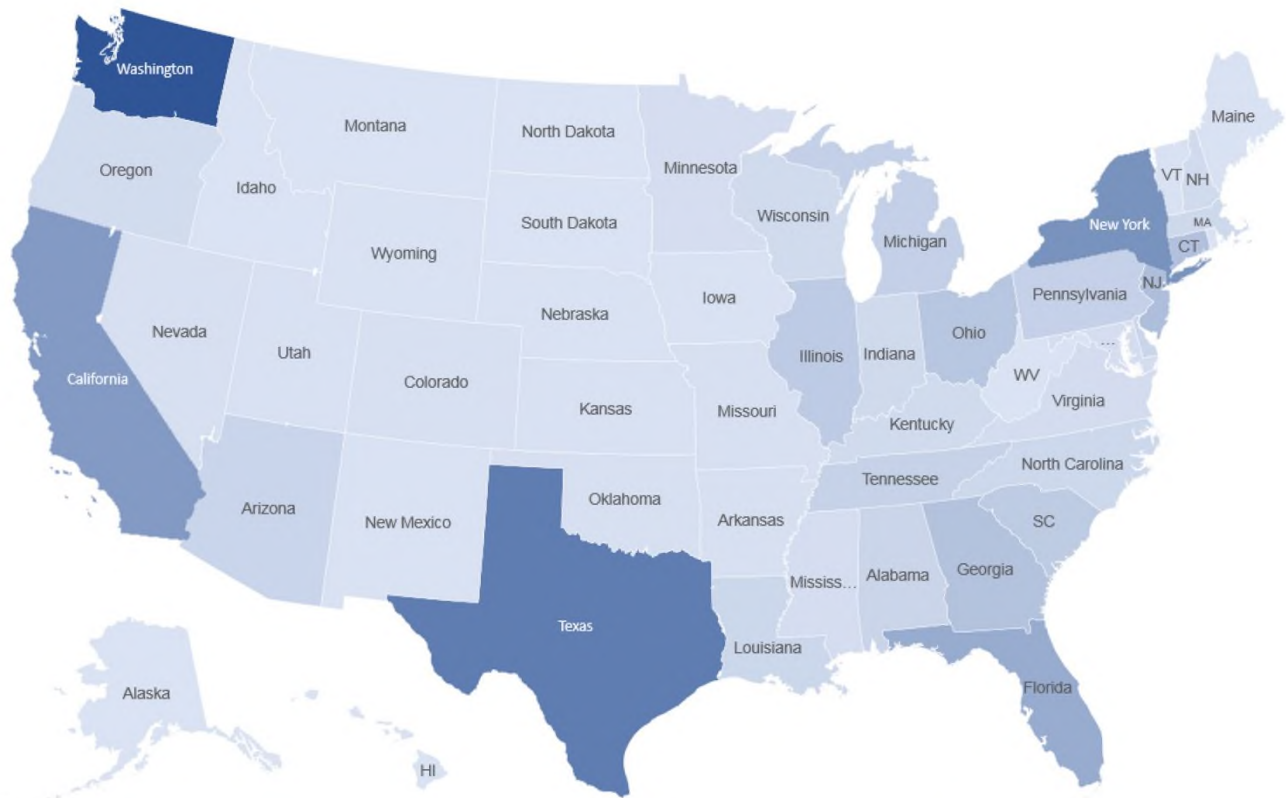

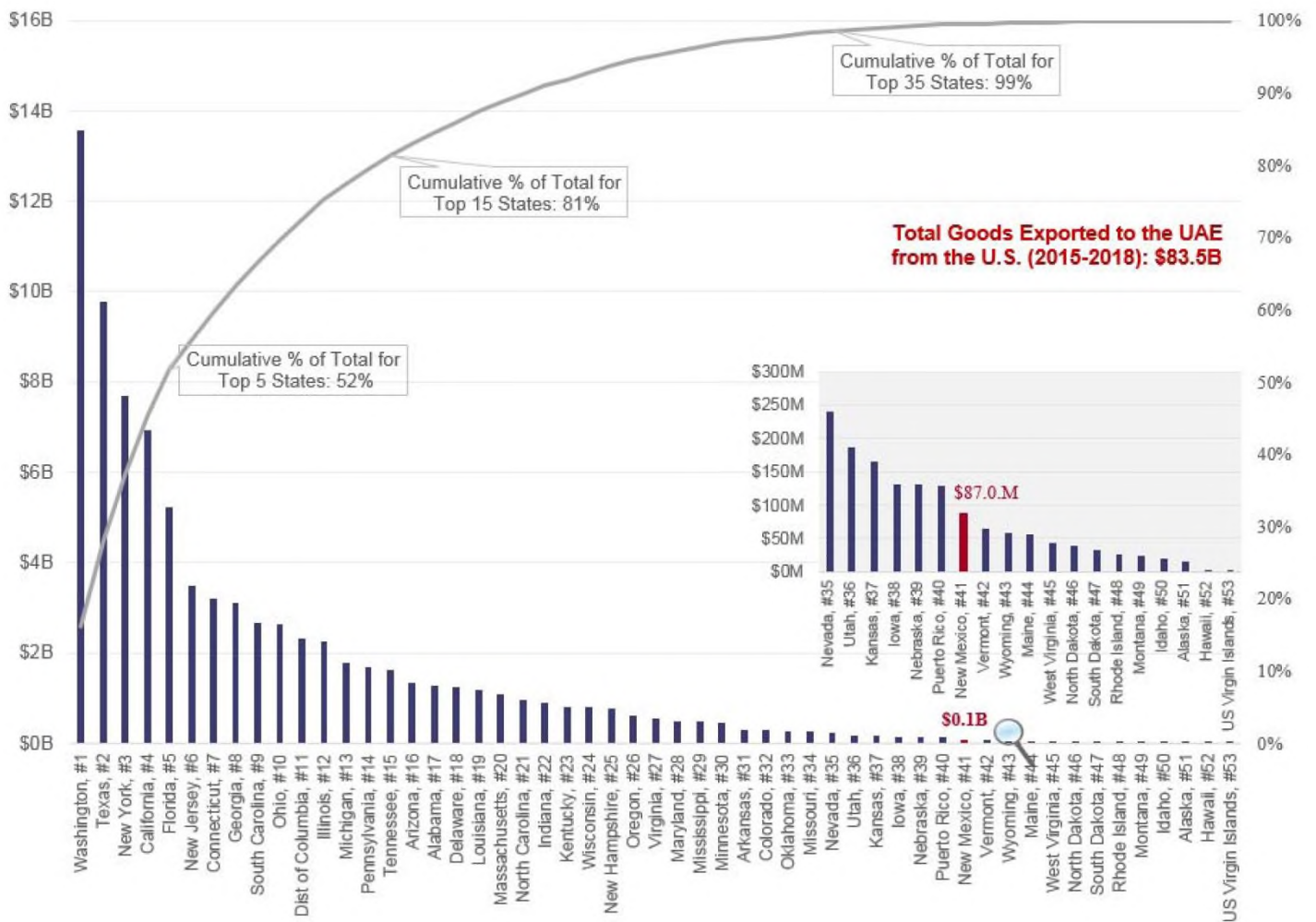

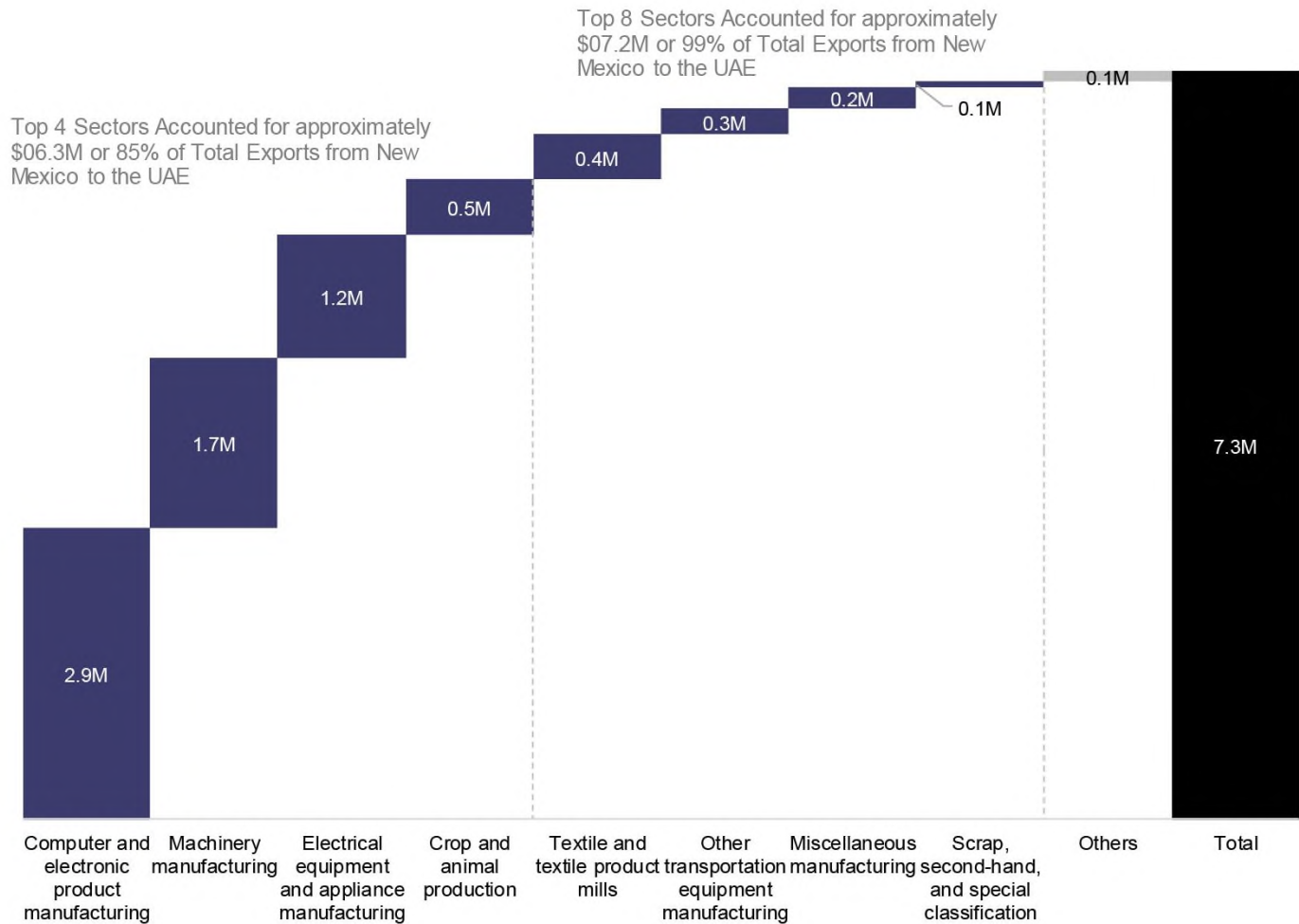


New Mexico Exports to the UAE

Exhibit I.3 | New Mexico's Exporting Sectors in 2018





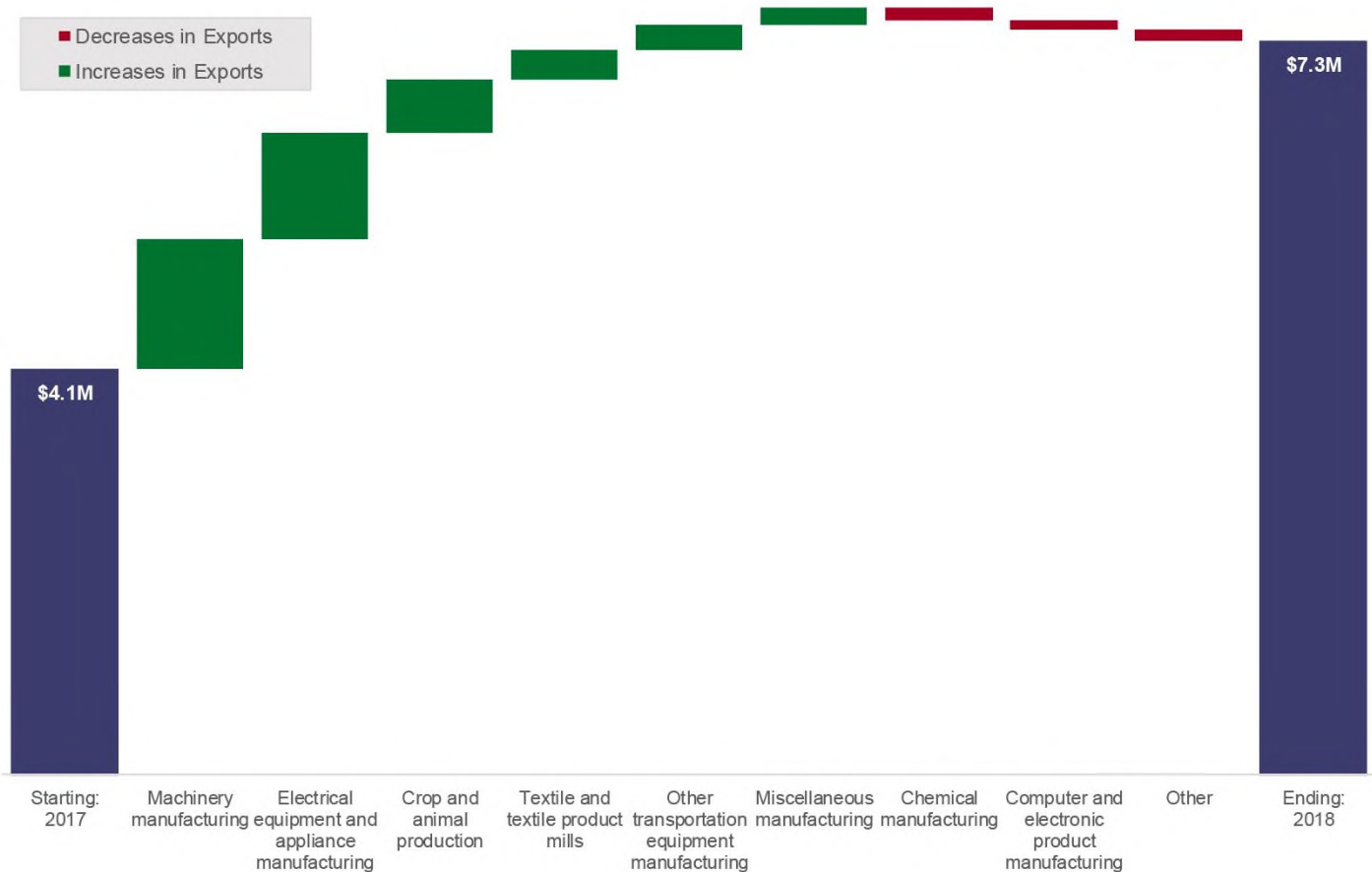

Exhibit I.4 | New Mexico's Exporting Sector Movements From 2017 to 2018

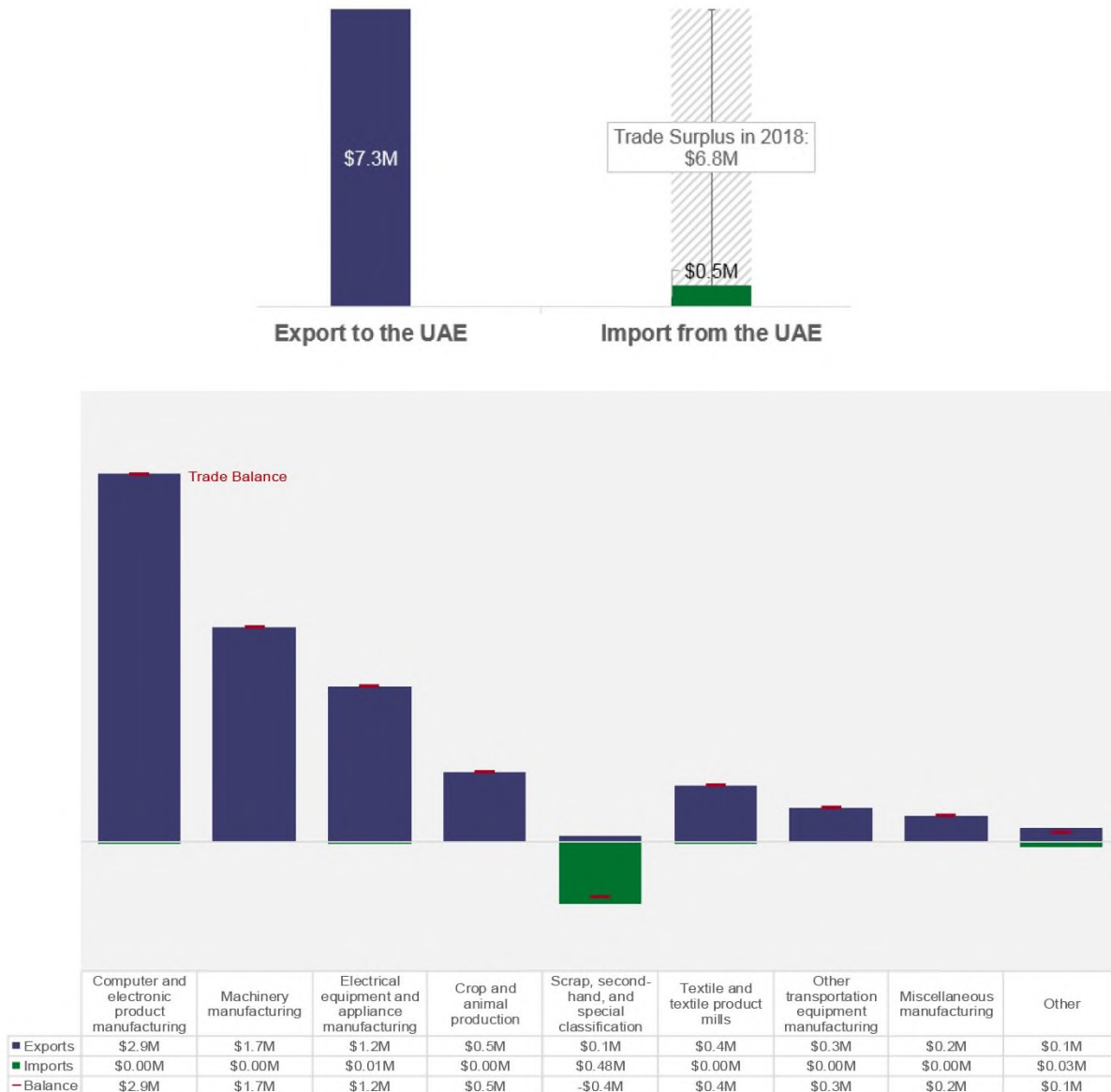

Exhibit I.5 | New Mexico's Trade Surplus with the UAE by Sector



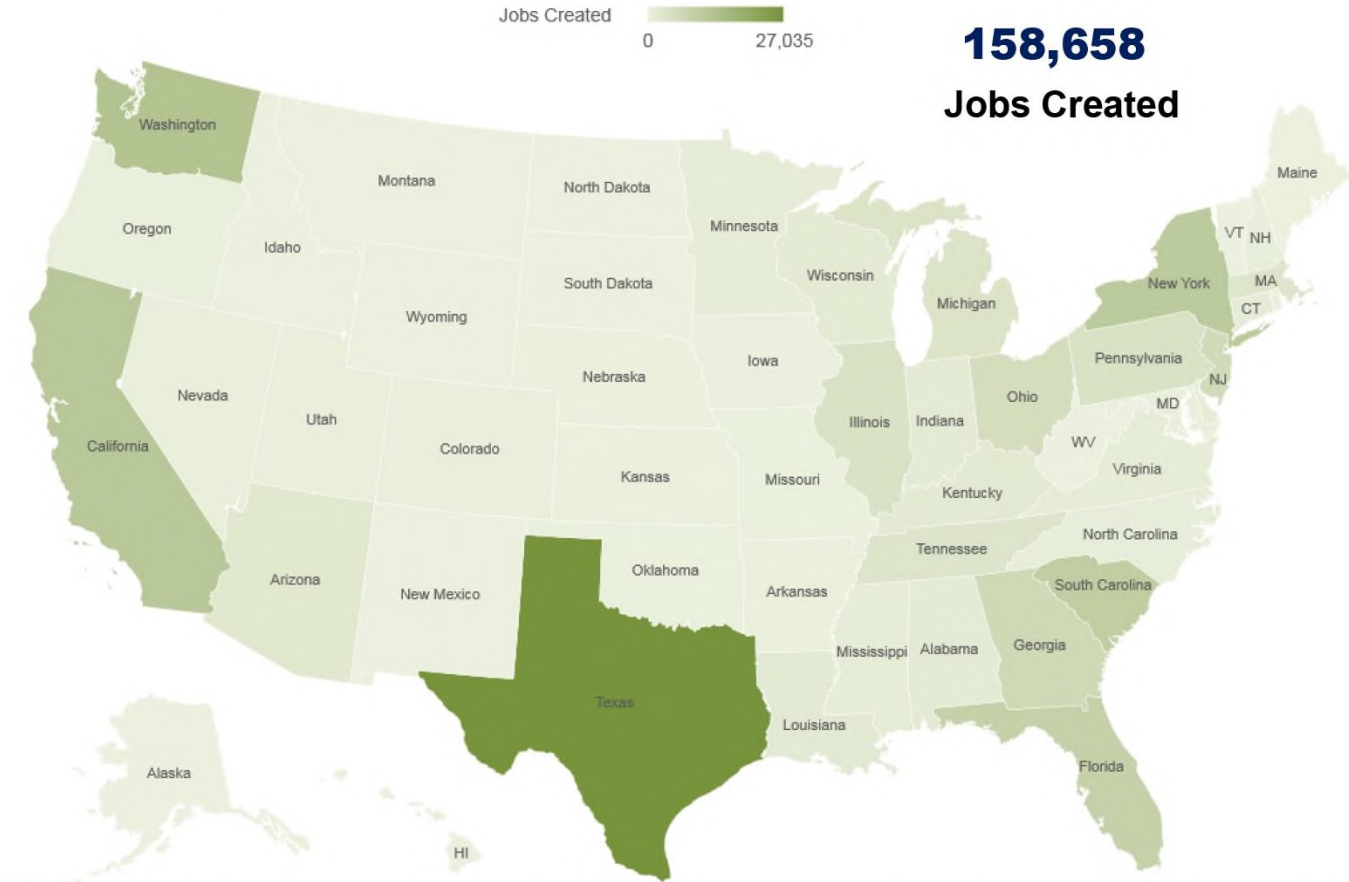

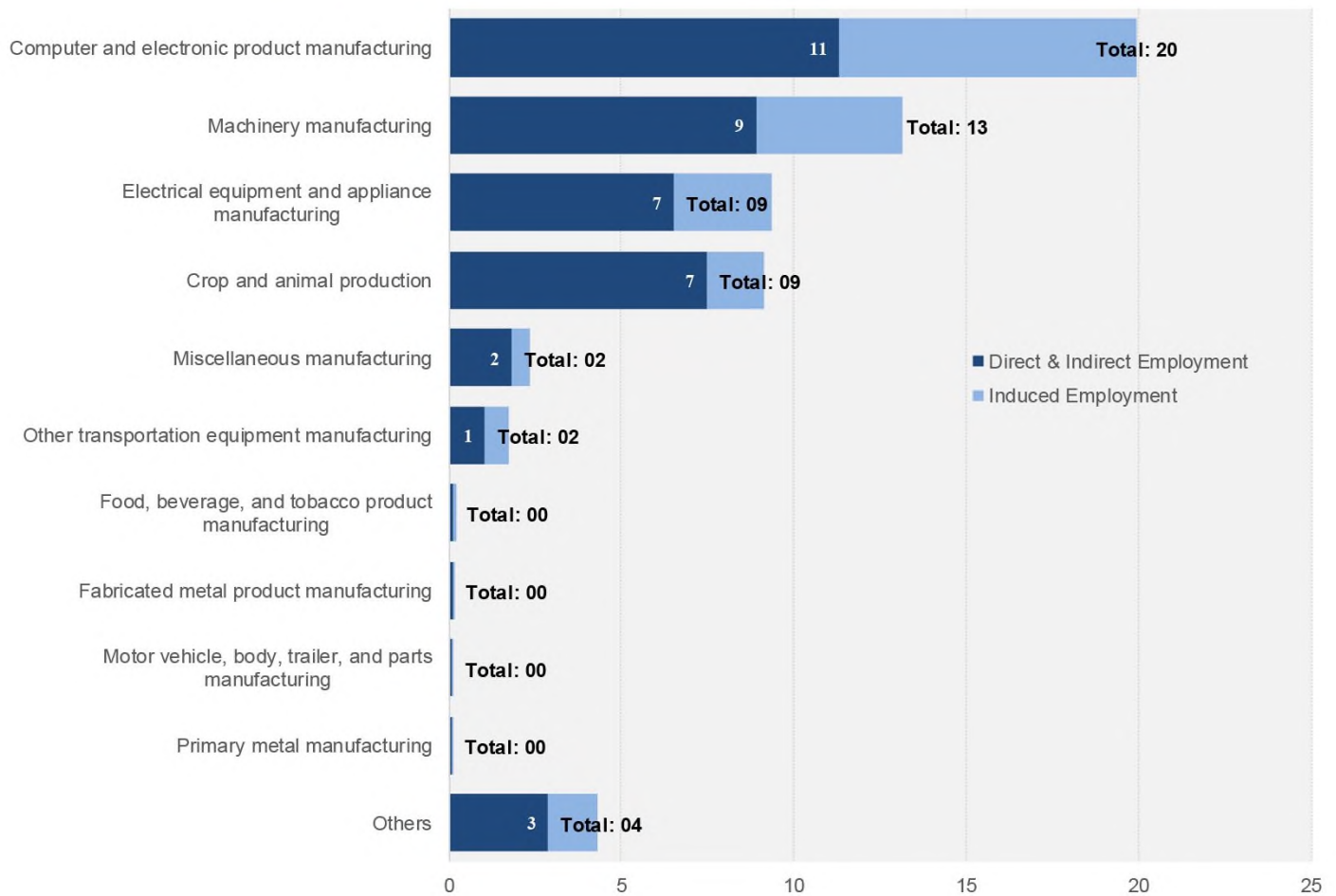

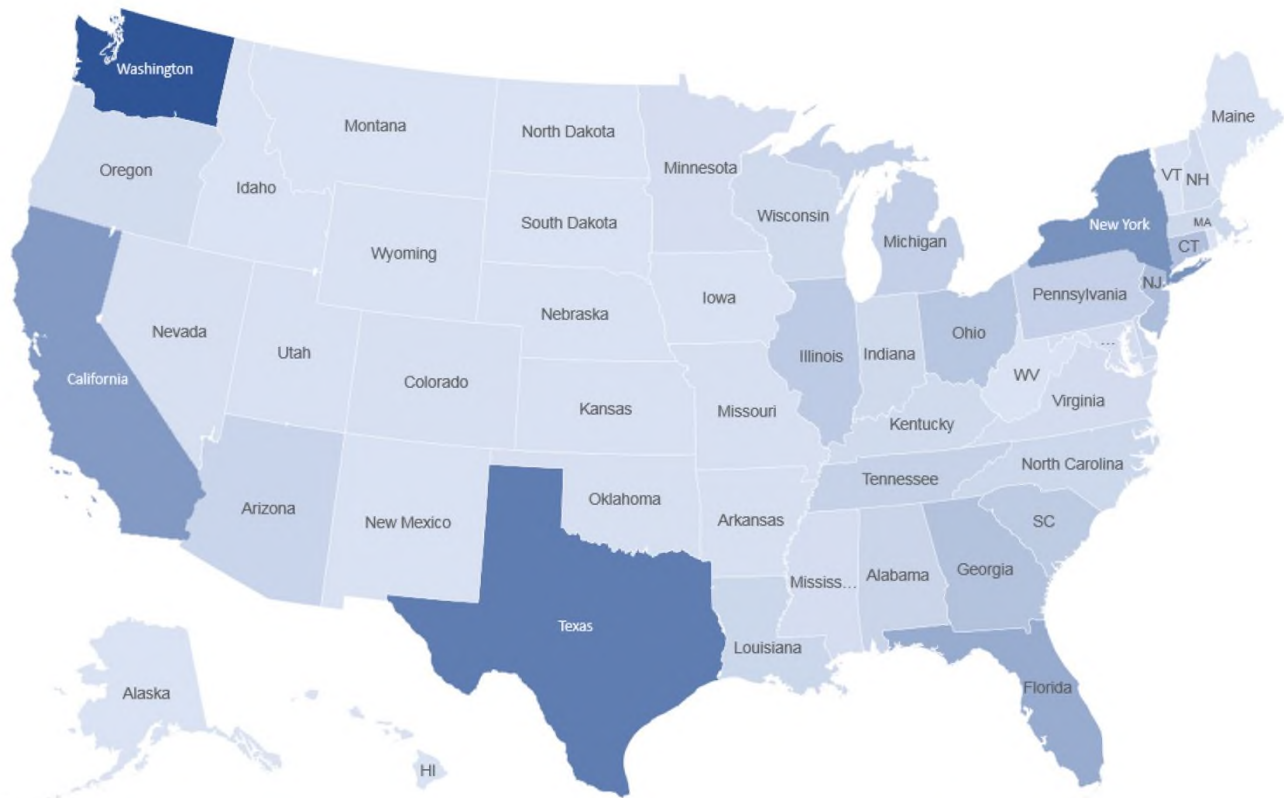

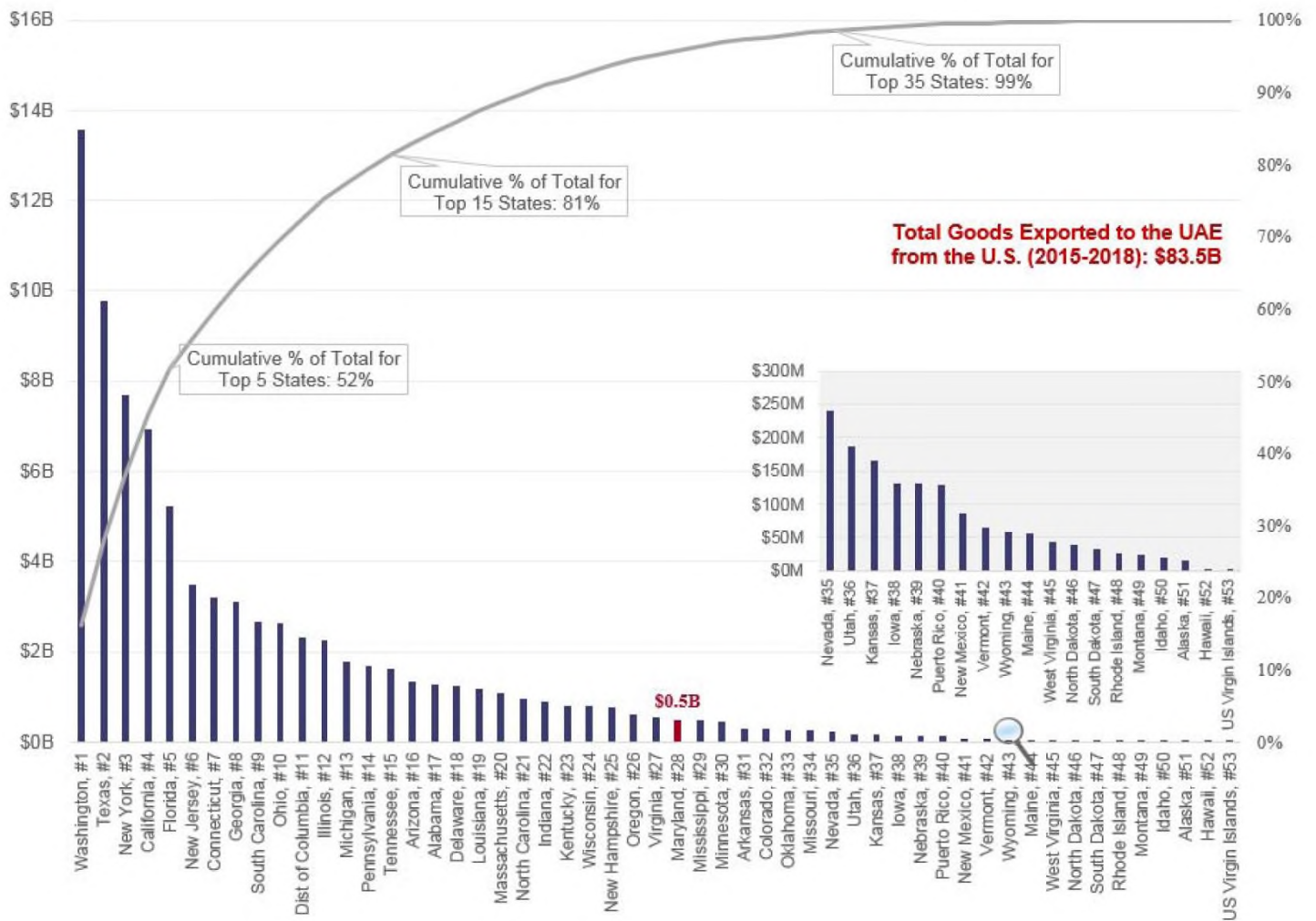

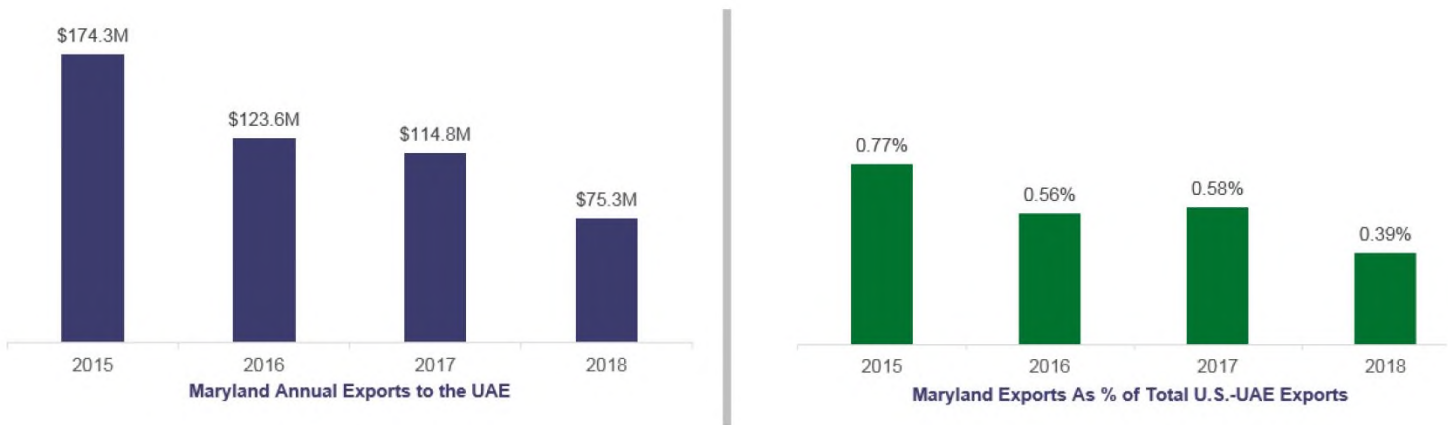

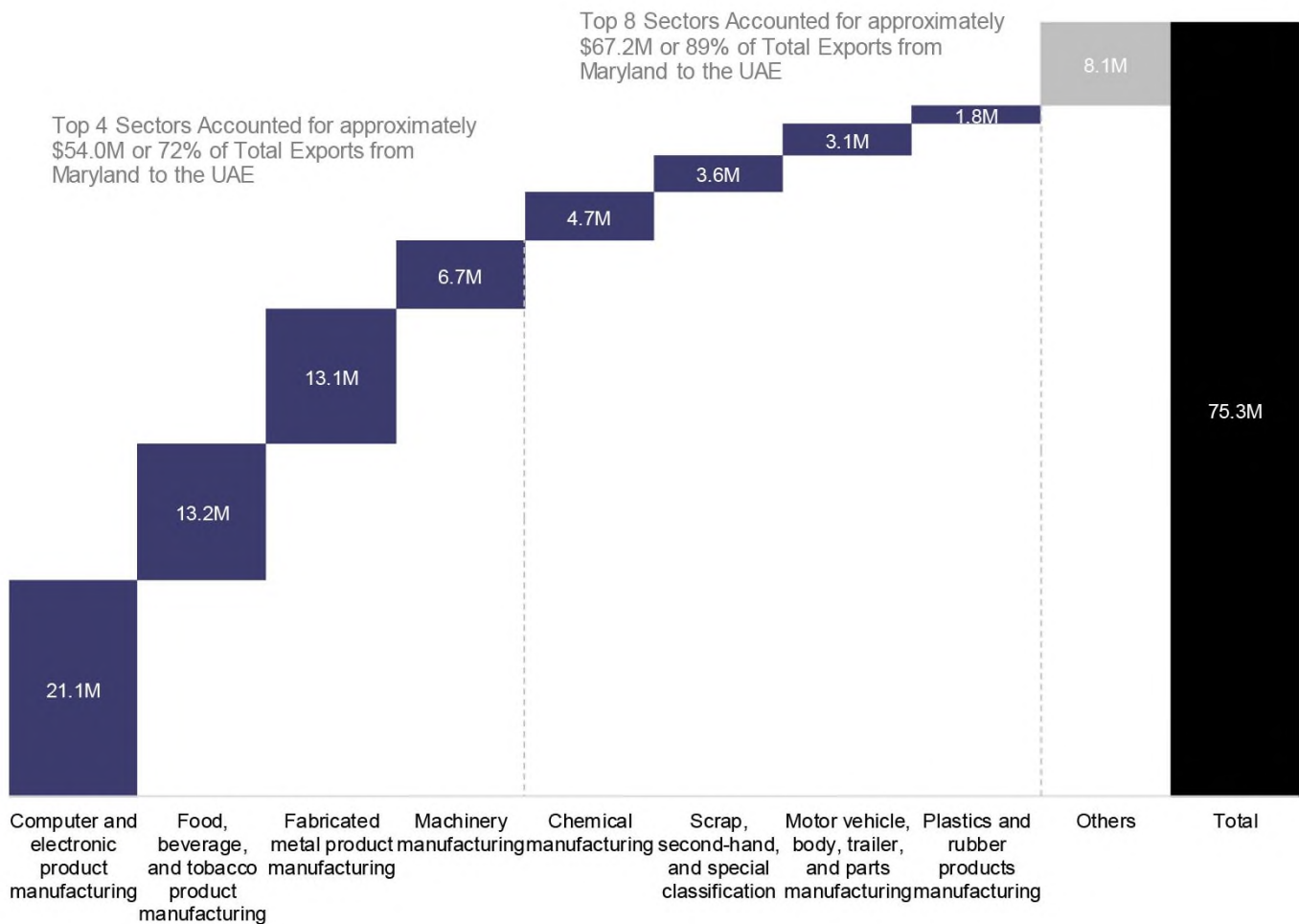


Maryland Exports to the UAE

Exhibit I.3 | Maryland's Exporting Sectors in 2018



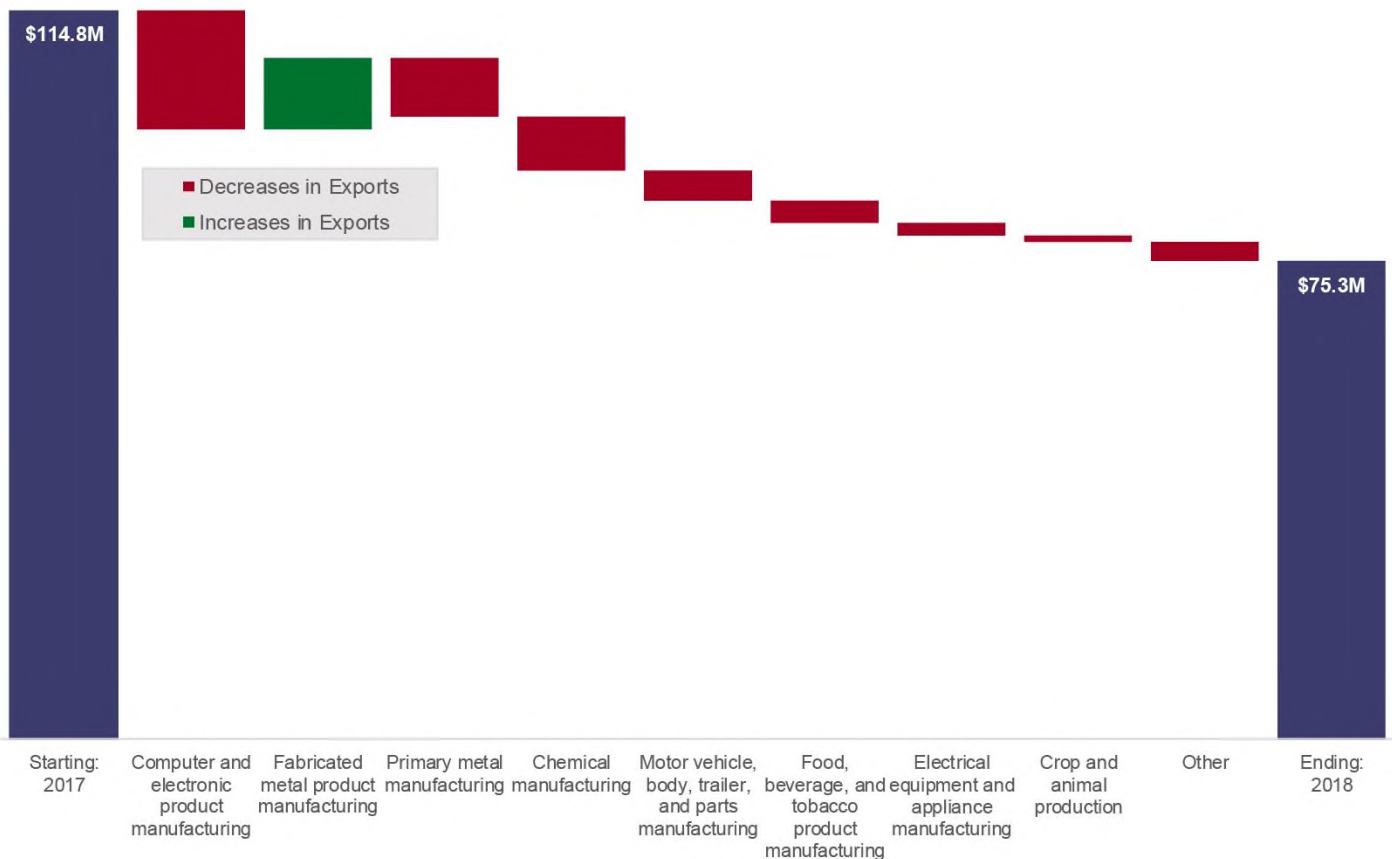

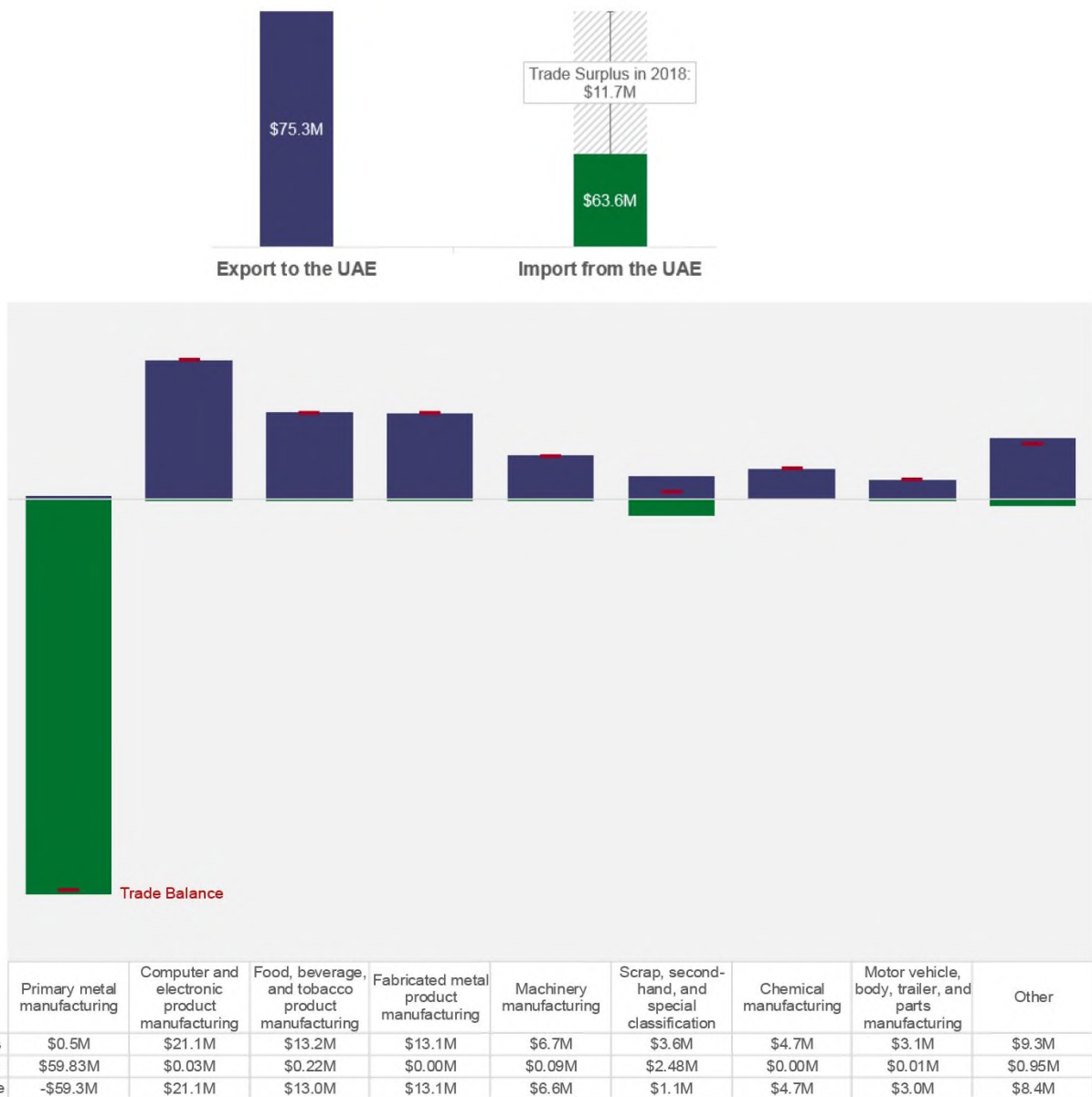

Exhibit I.5 | Maryland's Trade Surplus with the UAE by Sector



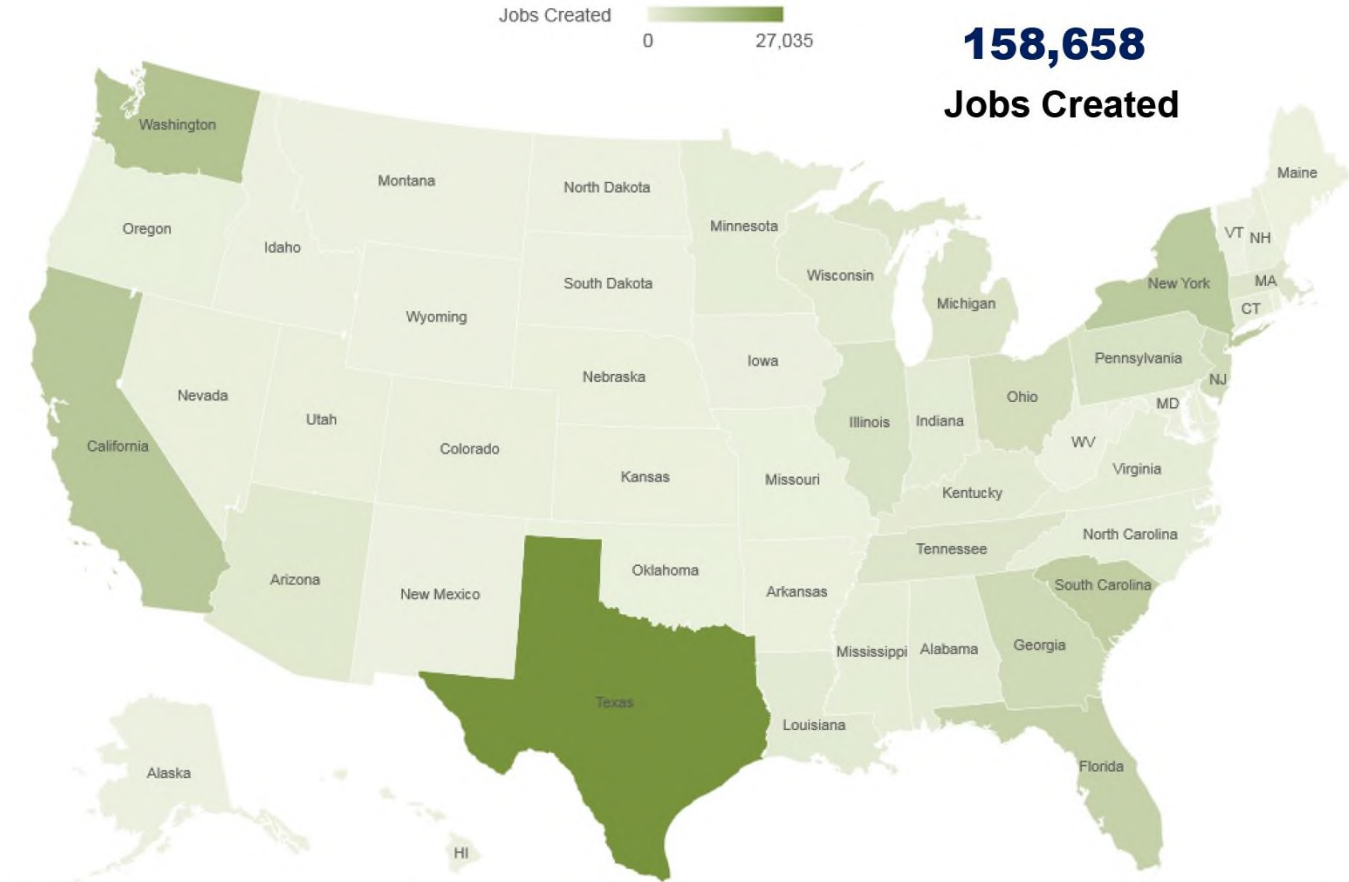

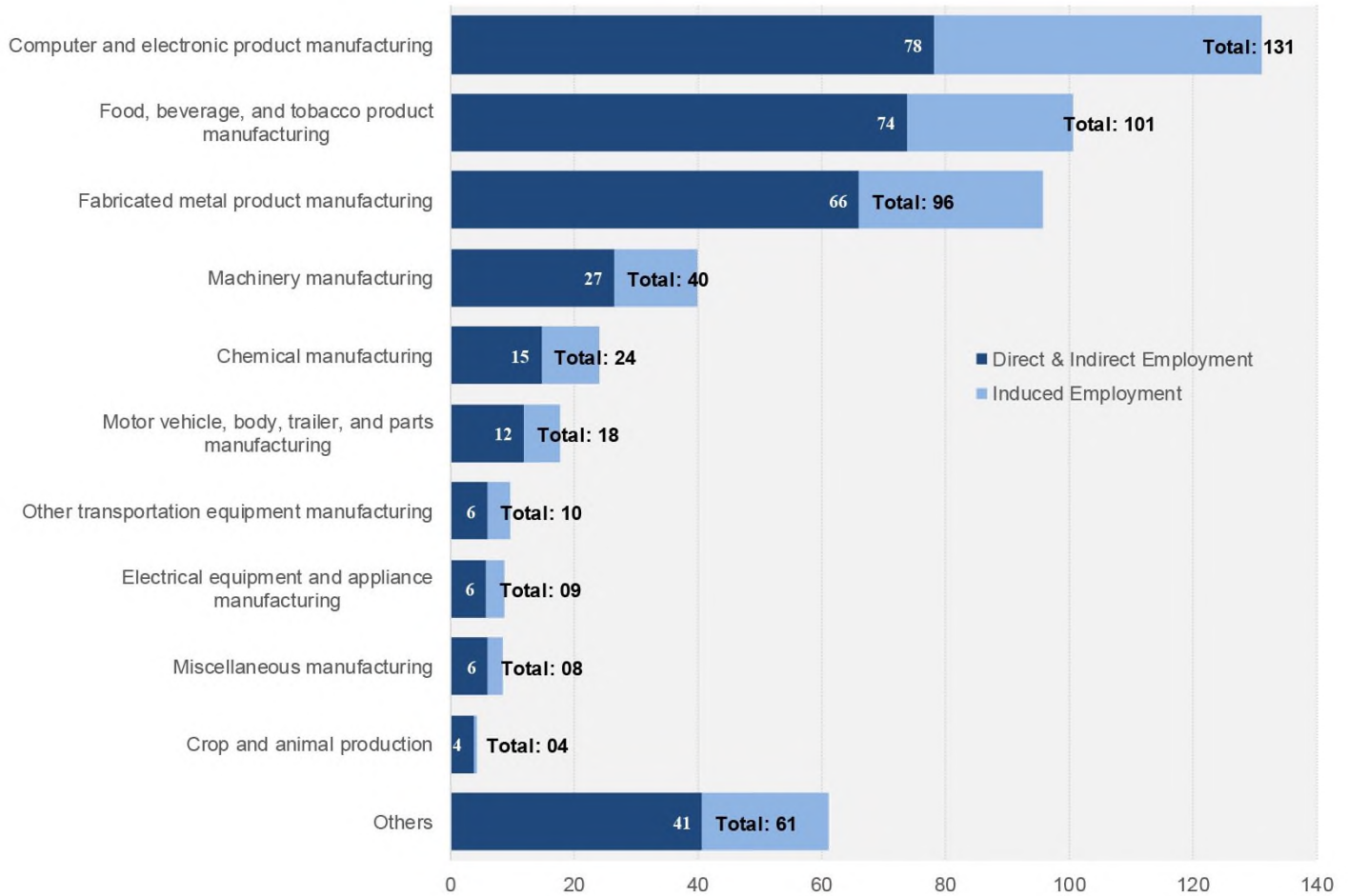

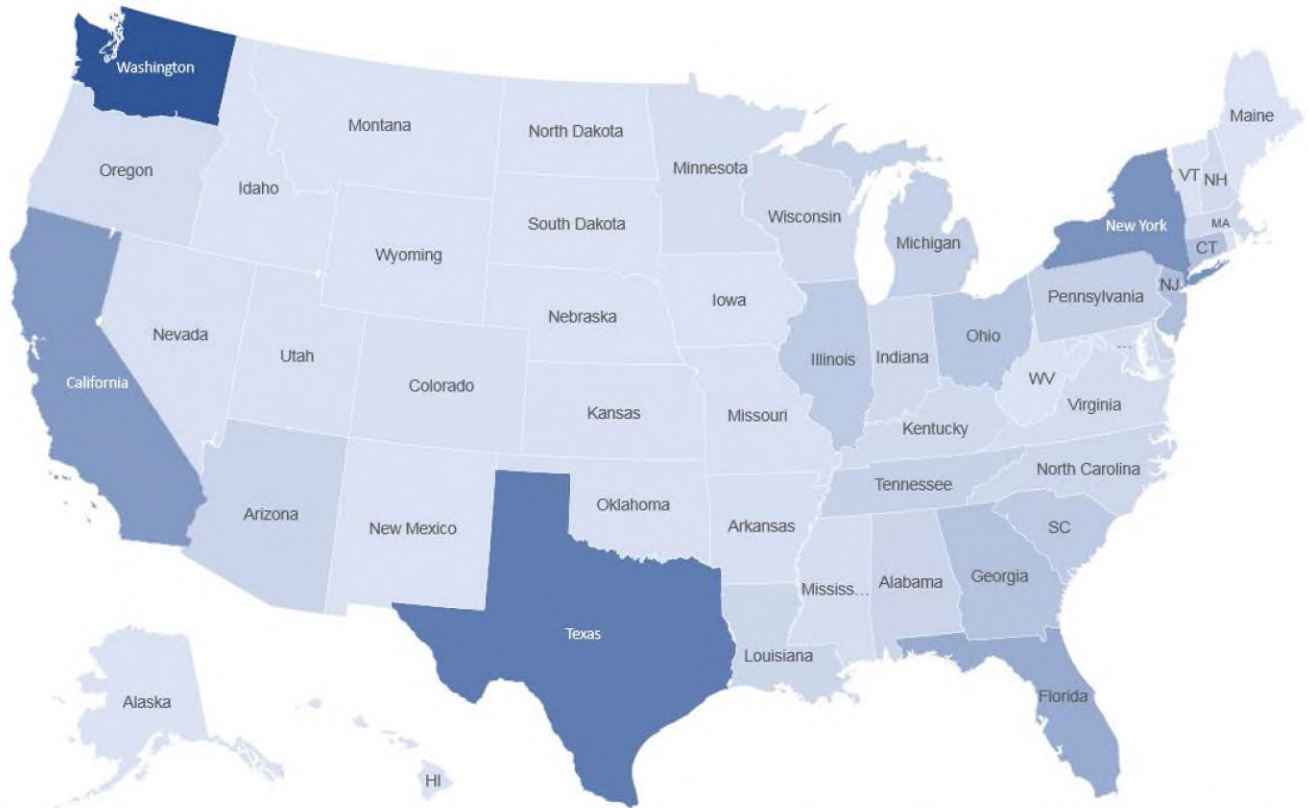

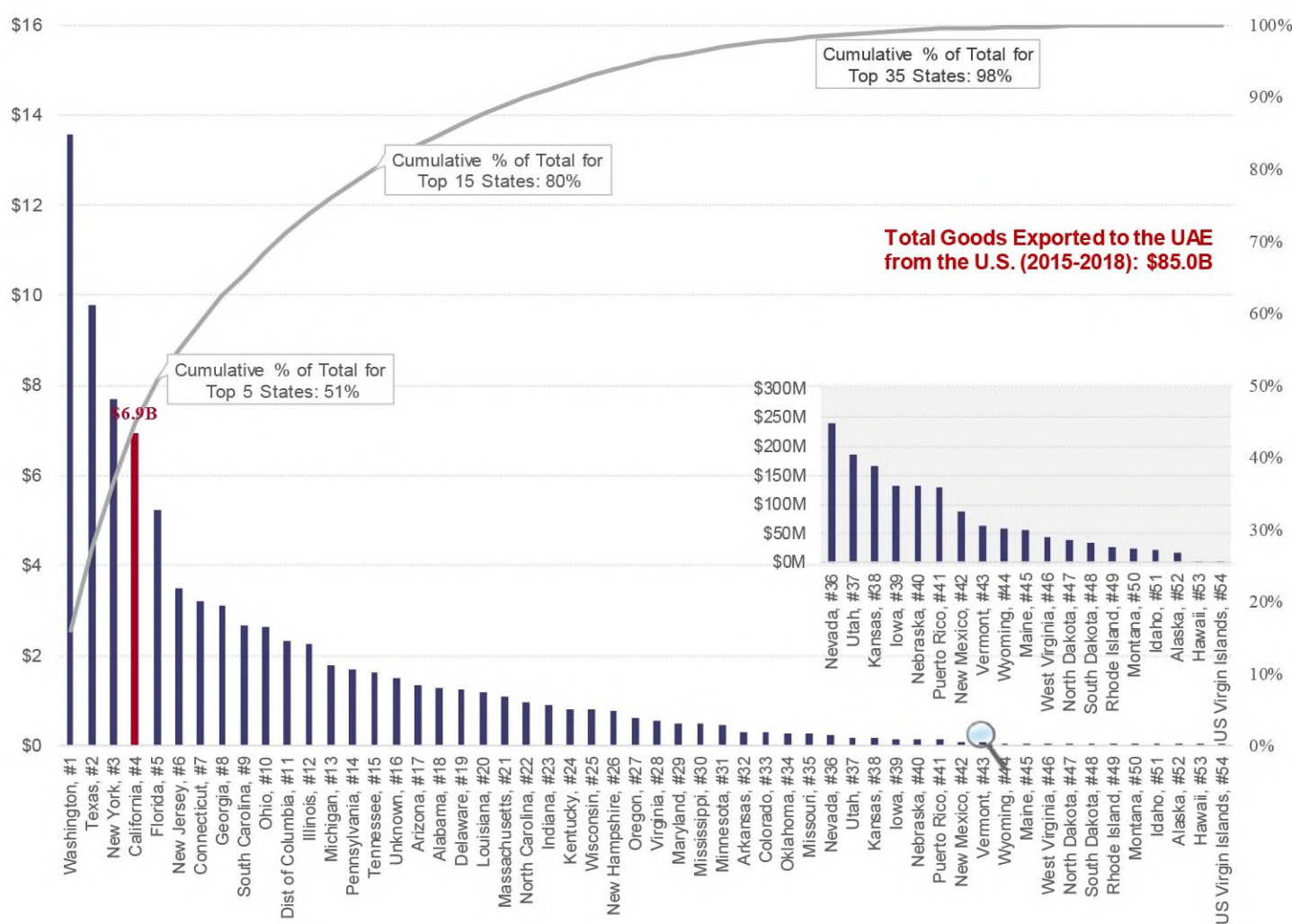

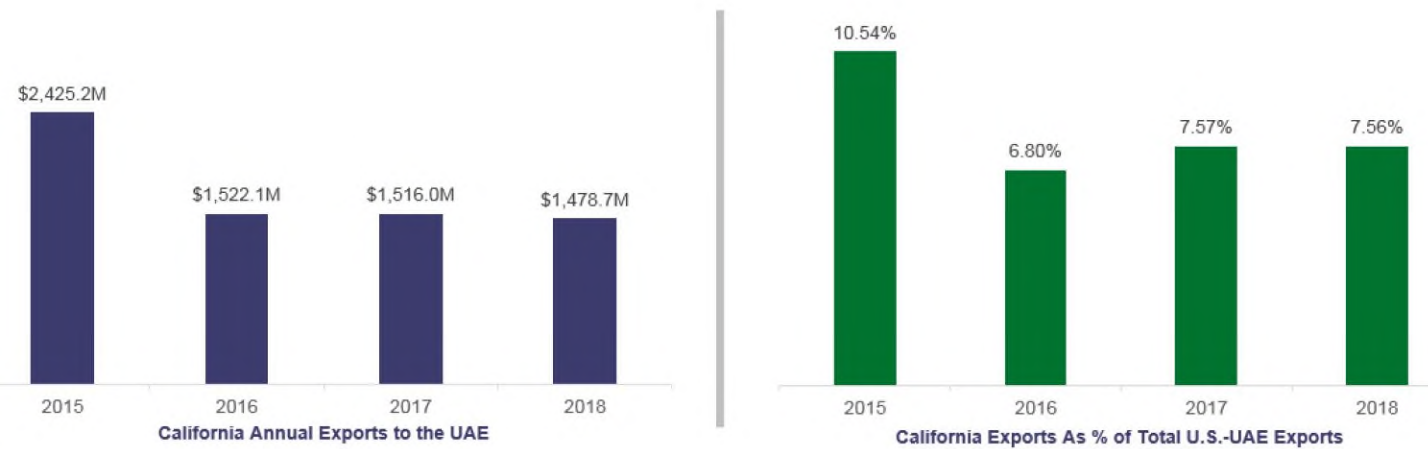

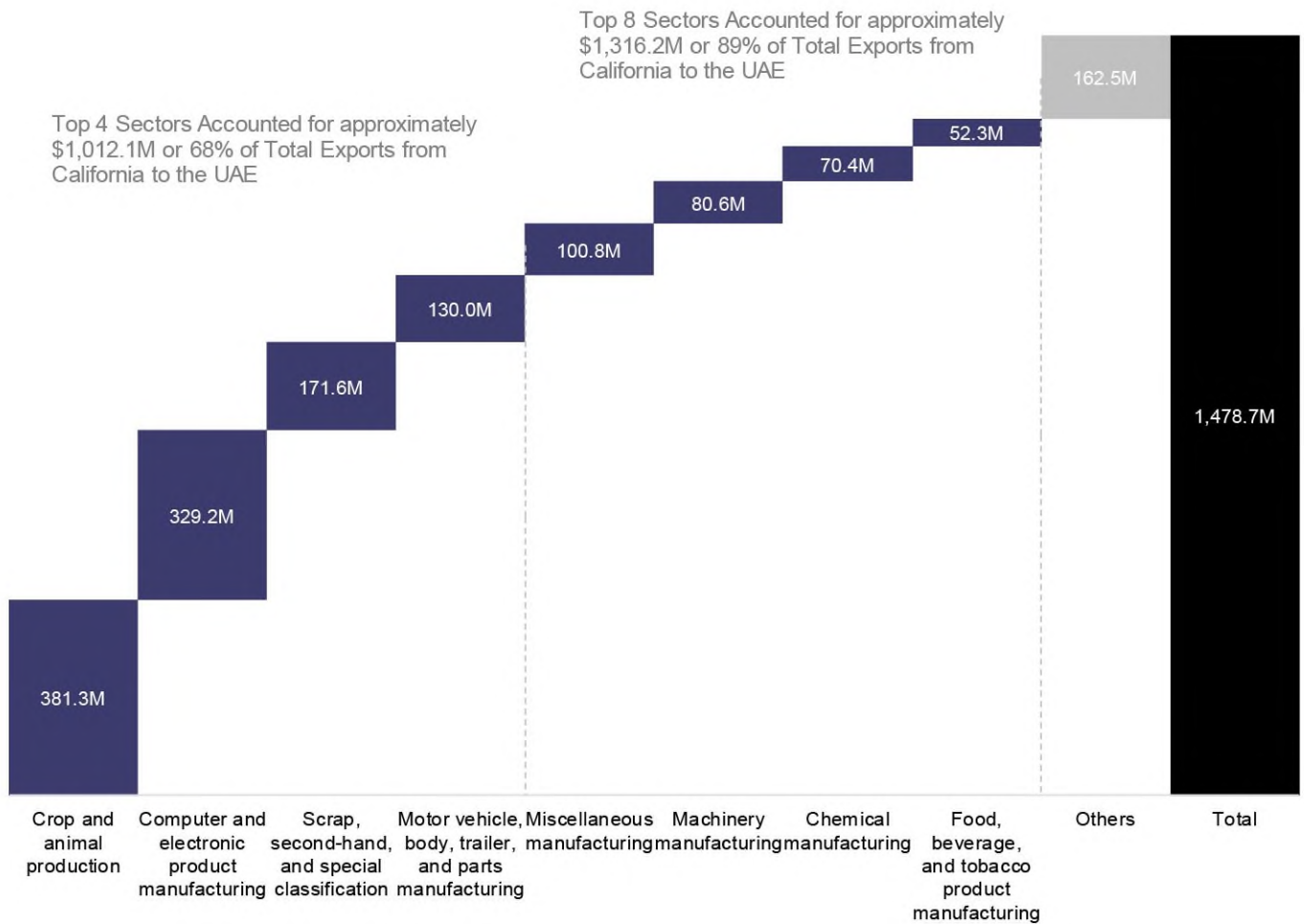

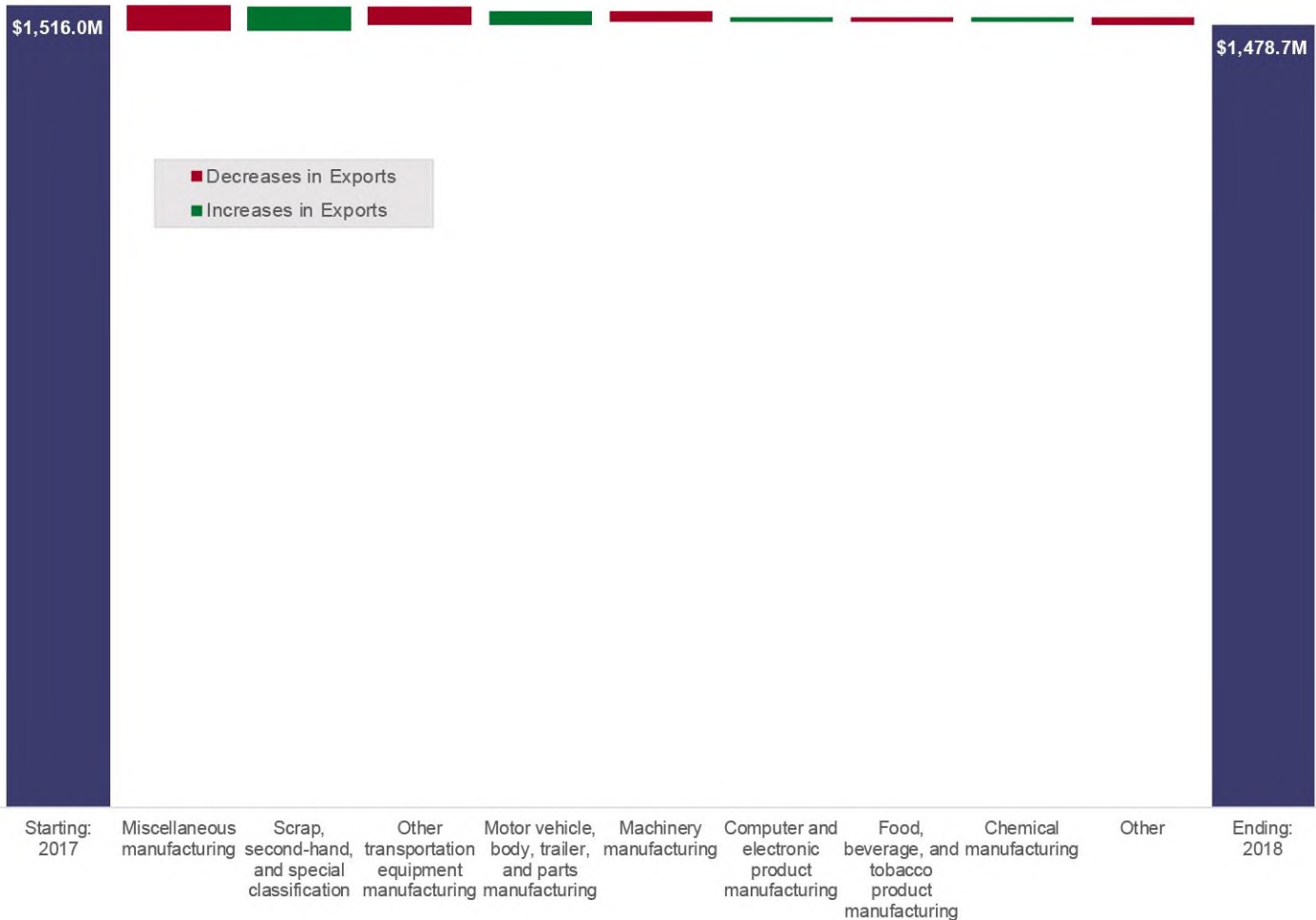

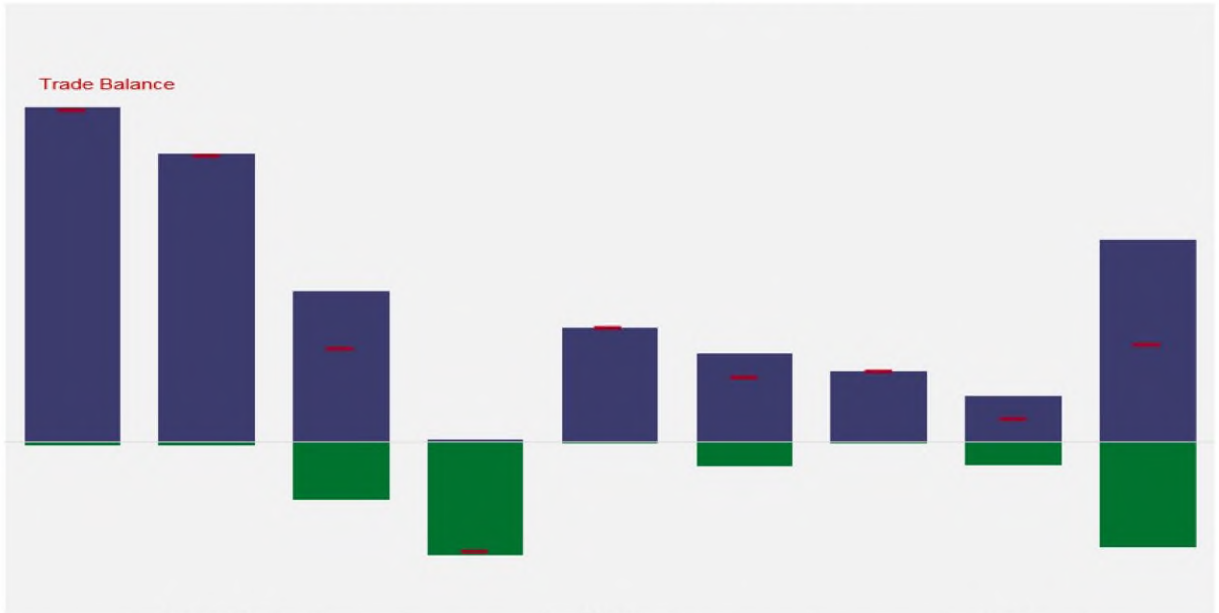
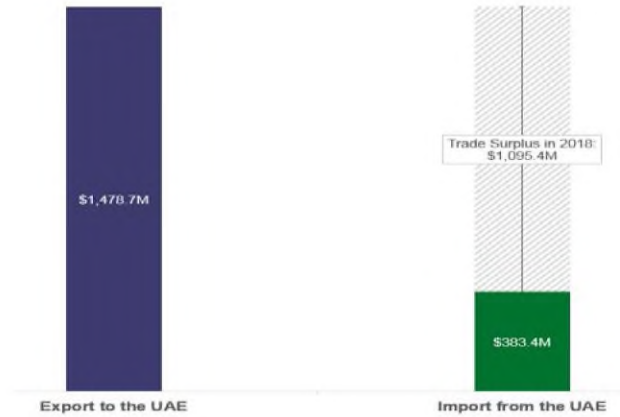

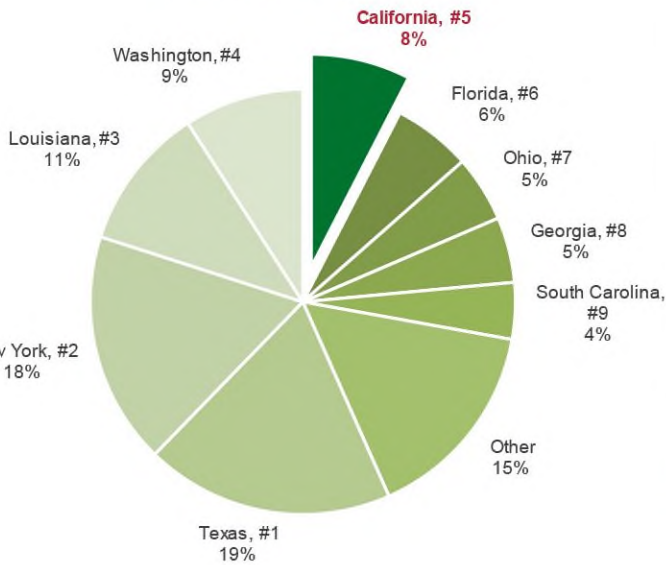
California – 2018 UAE Bilateral Port Activity



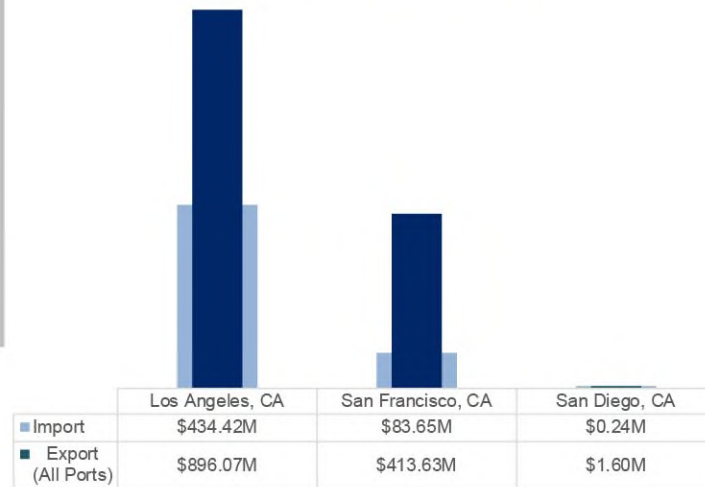

Total U.S.-UAE Port Activity

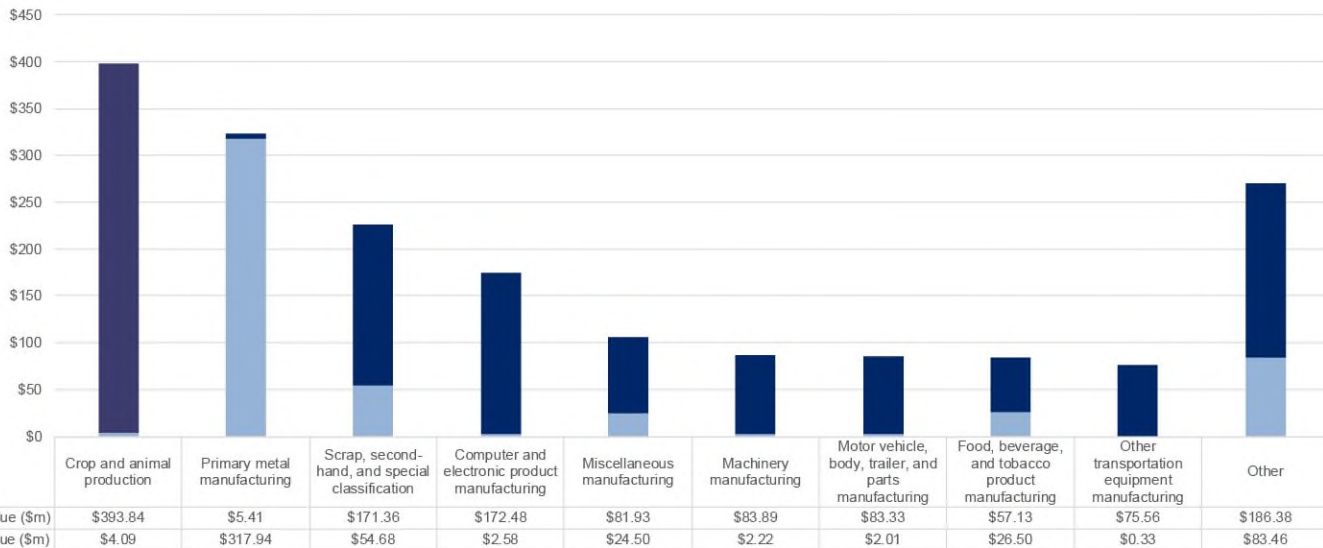


Port Activity by District

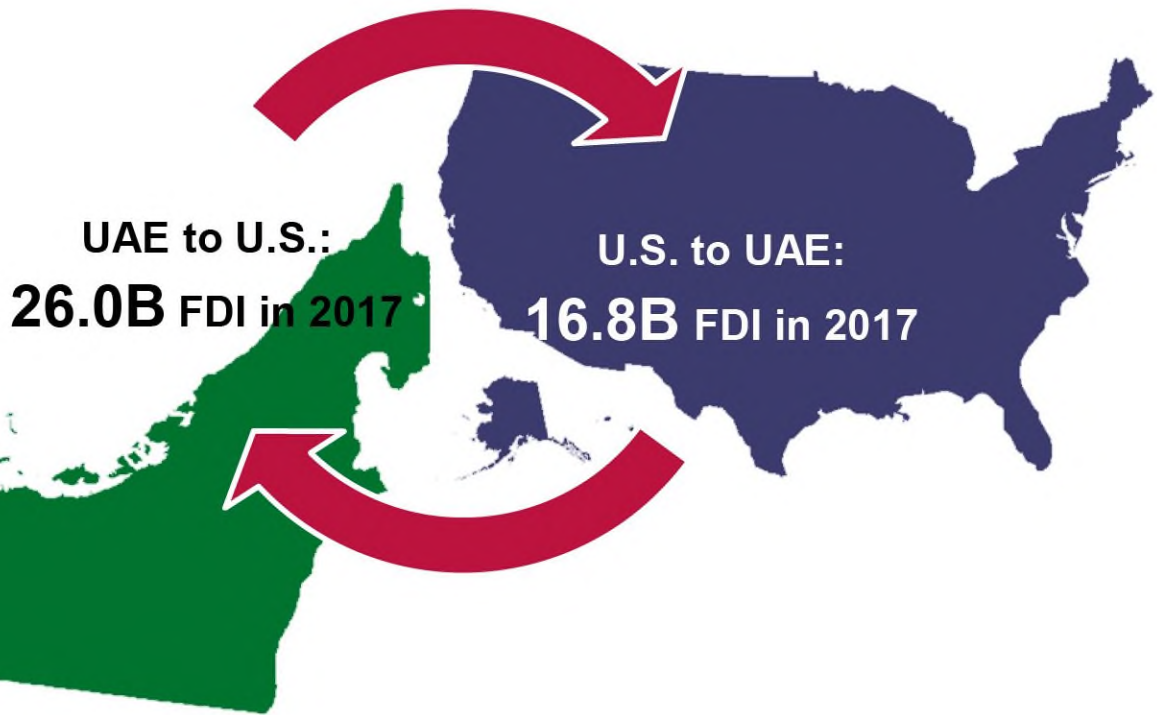

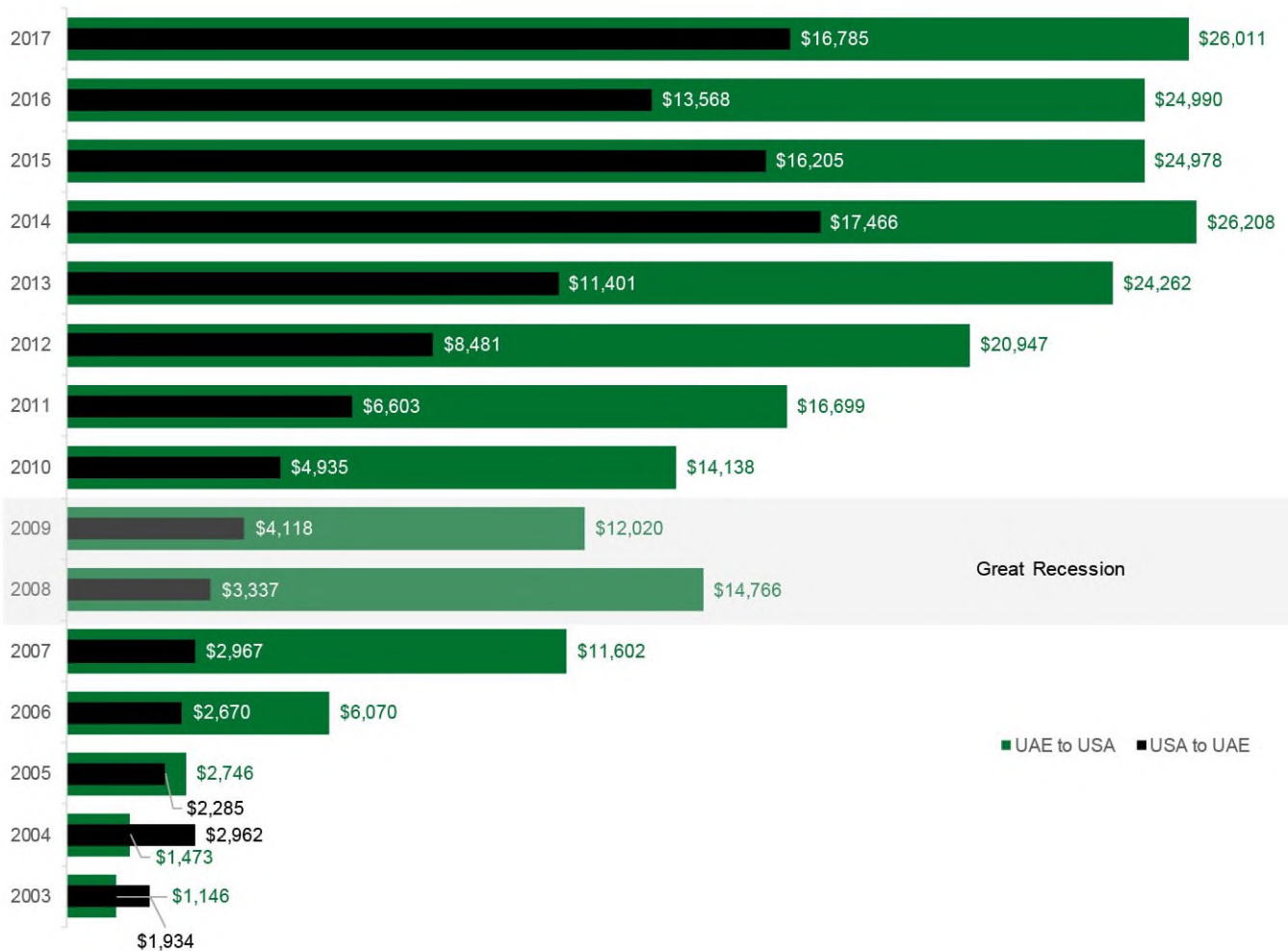

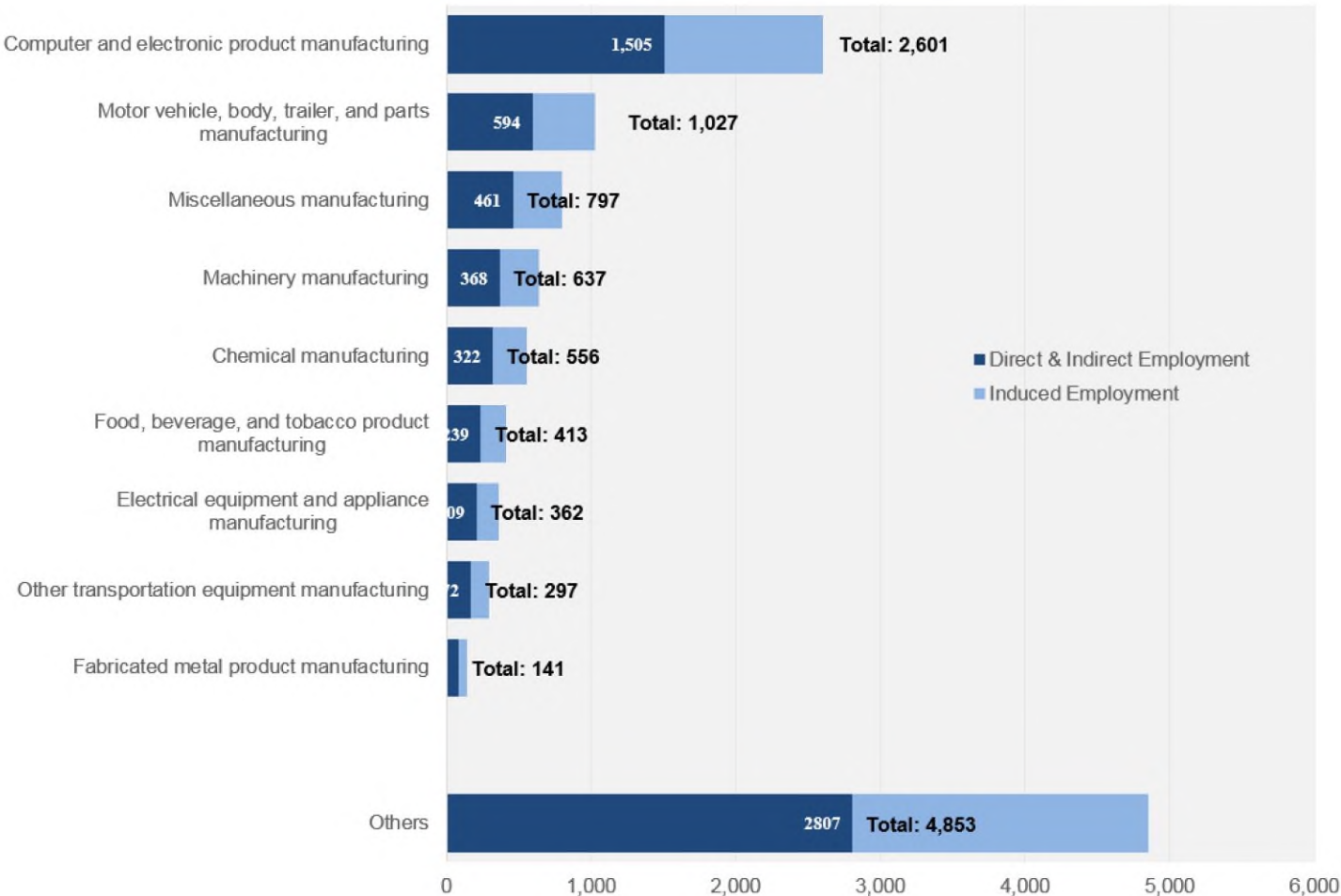
