## Consulting Agreement

This Advocacy Agreement ("Agreement") is made as of the date of full execution of this Agreement ("Effective Date"), between **The Centre for a European Future ("CEF")**, located at Rue des Poissonniers 13, 1000 Brussels, Belgium, and **Yorktown Solutions, LLC ("YTS")**, a strategic and political risk advisory firm located at 444 North Capitol Street NW, Suite 613, Washington, D.C. 20005.

### RECITALS

- A. YTS is a consulting firm that provides strategic advisory, advocacy, and public relations services.
- B. CEF desires to engage the advisory services of YTS, and YTS desires to provide advisory services to CEF upon the terms and conditions below.

**NOW, THEREFORE**, in consideration of the mutual promises hereinafter contained, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Advisory Duties. YTS will provide a mutually agreed amount of government and public relations services within the United States to promote CEF's Ukraine program focusing on promoting Ukraine's territorial integrity, humanitarian initiatives, and candidacy for membership of the European Union.
2. Term. YTS's duties under this Agreement shall commence on the Effective Date and continue until August 1, 2023.
3. Independent Contractor Status. It is understood that YTS is an independent contractor and is not an employee of CEF, and shall not hold itself out to the public as an employee of CEF. CEF will not provide, nor will it be responsible to pay for, any benefits for YTS.
4. Employees of Independent Contractor. YTS may, in its sole discretion, hire as many employees, contractors, or other persons as it requires in order to fulfill its obligations under Section 1 of this Agreement. CEF will be advised of the employment or hiring by YTS of such persons. If such persons are employees of YTS, then YTS shall be solely responsible for all necessary insurance and payroll deductions for such persons, including but not limited to, federal, state, and local

income taxes, Social Security taxes, unemployment compensation taxes, workers' compensation coverage, and any other fees, charges, or licenses required by law. If such persons are contractors of YTS, then the independent contracting relationship shall be established between such contractor and YTS exclusively, and YTS shall be responsible for directing the duties of such contractor and paying such contractor.

5. Business of Independent Contractor. YTS may engage in any other business that it desires and is not required to devote all its energies exclusively for the benefit of CEF.
6. No Solicitation. During the term of this Agreement and for a period of one year after its termination CEF will not for its purposes or on behalf of any other party or any of its affiliates, employ, take away, or attempt to take away any YTS employee or contractor involved in the services set forth herein, unless CEF has received the prior written approval of YTS.
7. Discrimination. No person on the basis of handicap, race, color, religion, sex, sexual orientation, age, or national origin, will be excluded from participating in, or be denied benefits of, or be otherwise subjected to discrimination in the performance of this contract, or in the employment practices of YTS. YTS shall, upon request, show proof of such non-discrimination and shall post in conspicuous places available to all employees and applicants, notices of non-discrimination.
8. Compensation. In complete consideration for the services to be rendered under this Agreement, CEF shall pay YTS a a fixed fee of \$250,000 fee ("Fee") for the services and as an allowance for out-of-pocket expenses incurred in the execution of the services. The maximum amount payable by CEF for all fees, expenses, taxes, and other charges under this Agreement is the Fee unless YTS obtains CEF's prior written approval. The Fee can through mutual agreement of the parties in writing (Email correspondence is sufficient) be revised based on the communications and increased needs of CEF. Any changes to the Fee will take effect in the following month.
9. Invoice. YTS will submit equal monthly invoices CEF for \$50,000 each for March – July for the Fee set forth in Section 9 of this Agreement. The invoices will be submitted by YTS to CEF monthly in arrears, and payment is due within 30 calendar days of receipt of the invoice.
10. Expenses. In the event that YTS seeks to incur actual and justified expenses in the course of performing services, then YTS shall obtain CEF's prior written

approval for all such expenses and such expenses pre-approved in writing shall be invoiced monthly in arrears.

11. **Disclosure and Confidentiality.** All non-public information given to YTS by CEF will be considered confidential information and shall be maintained as such by YTS until the same becomes known to third parties on a non-confidential basis or the public without release thereof by YTS, or unless YTS is required to disclose such information under applicable law, *provided*, that in such instance, YTS shall notify CEF as promptly as possible of such obligation to release confidential information. YTS shall take all necessary steps to safeguard the confidentiality of such material or information. YTS will give CEF notice as set forth herein before making such disclosure of non-public information. Further, YTS agrees to inform CEF immediately upon receiving reason to believe that persons or entities are seeking to obtain any confidential information from YTS.
12. **Governing Law.** This Agreement shall be subject to and governed by the laws of the District of Columbia, without regard to the conflict of law provisions thereof. Any dispute regarding the terms of this Agreement shall be brought in district or federal courts located in the District of Columbia.
13. **Legal Filings.** It is understood that YTS may be required to register under Title 22, Chapter 11 of the United States Code pertaining to the Foreign Agents Registration Act ("FARA") or the Lobbying Disclosure Act ("LDA") on behalf of CEF and thereafter will be required to file the reports required by FARA or LDA, detailing its activities under this Agreement on CEF's behalf. It is further understood that YTS will comply with all Federal statutes, regulations, and ethics rules governing its activities on behalf of CEF with the United States Congress and Federal Executive Branch departments and agencies.
14. **Termination of Agreement.** Either party may terminate this Agreement without cause for any reason with 30 days prior written notice, and such termination shall not be deemed a breach by the other party. In the case of a material breach by the other party, this Agreement may be terminated immediately. In the event of a termination of this Agreement (whether or not for cause) CEF shall remain liable for all fees and expenses pre-approved in writing incurred by YTS up to the date of termination, as well as amounts that YTS is obligated to pay to third parties pursuant to non-cancelable agreements YTS has entered into in performance of this Agreement where such amounts have been pre-approved in writing by CEF for CEF to be pay such amounts.
15. **Waiver.** The waiver by either party of any covenant, obligation, or breach of this

Agreement shall not operate as, or be construed as, a waiver of any other such covenant, obligation, or breach hereof.

16. **Modification.** No change, modification, or waiver of any term of this Agreement shall be valid unless it is in writing and signed by both parties.
17. **Entire Agreement.** This Agreement constitutes the entire agreement between the parties and supersedes all prior agreements or understandings between CEF and YTS regarding the matters related hereto.
18. **Severability.** If any terms of this Agreement are held to be invalid or unenforceable as a matter of law the other terms and conditions hereof shall not be affected thereby and shall remain in full force and effect. To this end, the terms and conditions of this Agreement are declared severable.
19. **Indemnification.** (a) Each party agrees that it will indemnify and hold harmless the other party, its officers, employees, agents, subsidiaries, and affiliates, and the officers, employees, and agents of such affiliates, from and against any and all losses, claims, damages, liabilities, costs or expenses (including reasonable attorney's fees) (collectively, "Claims") incurred which are related to or arise out of or are in connection with any negligence or willful misconduct by the indemnifying party in connection with this Agreement. In the case of any negligent action on the part of YTS, YTS agrees that it will indemnify and hold harmless CEF from any and all Claims arising out of or in connection with such negligence. The obligations in this Section 19 shall survive the termination of this Agreement and are in addition to any liability which an indemnifying party may otherwise have, and shall be binding upon and inure to the benefit of any successors, assigns, heirs, and personal representatives of the indemnified party.
20. **Headings.** The headings are inserted for convenience and shall not be considered when interpreting any of the provisions or terms hereof.
21. **Signature Authority.** Each of the signatories to this Agreement warrant and represent that they have the full legal authority to execute this Agreement and that they are duly authorized to bind the entity on behalf of which they have executed the Agreement.
22. **Notices.** Whenever notices are required to be given under this agreement, such notices shall be sufficiently given or made if in writing and sent by certified mail, return receipt requested, addressed as follows:




