Summary of Discussion:

For those of you who were unable to attend, co-author of the World Resource Institute's *Creating a Sustainable Food Future* report, Tim Searchinger, spoke about how global agriculture will need to adapt in order to achieve a sustainable food future while meeting growing demands for food as our global population continues to increase. Tim spoke specifically about the need to limit land demand for biofuels and bioenergy.

Mat Jacobson focused his presentation on the role private companies play in the deforestation of tropical ecosystems. While many U.S. companies, like Cargill, McDonald's and Walmart, signed the New York Declaration for Forests pledging to eliminate deforestation from their supply chain by 2020 and end it by 2030, they have not been able to realize these goals. Mat recommended forest financing, limits on bioenergy, and the prohibition of the import of commodities grown on illegally deforested land as policies that would remove illegal deforestation from U.S. commodity supply chains.

The Environmental Investigation Agency's Rick Jacobsen covered illegal deforestation, international trade, and the United States market. An estimated 50% of deforestation in the tropics is driven by illegal conversion of forest for agriculture, thus creating unfair market competition for producers of raw commodities in the United States. A new bill from Senator Schatz, would restrict access to U.S. markets for commodities that originate from illegal deforested land, would allow U.S. producers to no longer compete with international products grown or raised illegally on deforested land.
