

National Council of Resistance of Iran	<p>During the period covered by the supplemental statement, the registrant co-signed four open letters/public statements and one letter to the U.S. Secretary of State in support of the members of the NCRI/MEK and a free Iran. Specifically, these letters: expressed support for Members of Congress who passed a resolution supporting the Iranian people's desire for regime change and criticizing the Iranian regime's human rights violations; criticized Belgium's release of Assadollah Assadi, an Iranian diplomat convicted of an attempted terrorist bombing; expressed support for NCRI/MEK and a free Iran; urged respect for the rights of MEK members residing in Albania; and expressed concern over an Albanian raid on MEK members residing in Albania, and urged that the U.S. oppose Iran's influence on the Albanian government and support the rights of MEK members residing in Iran. In addition, the registrant participated in a panel discussion at an open meeting of the NCRI/MEK in Paris, France on June 30, 2023 discussing U.S. policy toward NCRI/MEK and the litigation that resulted in the removal of NCRI/MEK from the State Department's Foreign Terrorist Organizations list. The registrant also spoke at a presentation of a copy of the open letter supporting NCRI/MEK and a free Iran to Mrs. Maryam Rajavi of MEK/NCRI.</p>

Response to Item 12-Description

National Council of Resistance of Iran: As described in Item 11, the registrant co-signed four open letters/public statements and one letter to the U.S. Secretary of State in support of the members of the NCRI/MEK and a free Iran during the period covered by the supplemental statement. In addition, the registrant participated in a panel discussion at an open meeting of the NCRI/MEK in Paris, France on June 30, 2023 discussing U.S. policy toward NCRI/MEK and the litigation that resulted in the removal of NCRI/MEK from the State Department's Foreign Terrorist Organizations list. The registrant also spoke at a presentation of a copy of the open letter supporting NCRI/MEK and a free Iran to Mrs. Maryam Rajavi of MEK/NCRI. These events were open to the press. The registrant did not engage in direct communications with U.S. government officials or members of the media.
