On April 30, 2023, Qorvis Holding Inc. (FKA Qorvis Communications) filed an Exhibit C reflecting its new corporate structure. There is a draft contract under consideration for the registrant to continue acting as a subcontractor for Qorvis Holding Inc.'s (FKA Qorvis Communications) work for The Kingdom of Saudi Arabia. The agreement will be filed as soon as it is executed by both parties. It is anticipated that the contract will call for the registrant to continue to conduct quantitative surveys on American attitudes and perceptions of Middle East and current event issues.
