The agreement between Moonlight International, LLC and the principal is the result of an oral communication and an understanding to support the foreign principal's visit to Washington, D.C., facilitate interactions with high-level academia representatives, government officials in charge of health sector and foreign affairs, private sector and international organizations, in order to set up preliminary relationships for COVID-19 pandemic response in Ecuador. The duration of the agreement is set to cover Dr. Borrero's visit to Washington DC and not to exceed a week starting on March 23, 2021, unless the parties agree otherwise. No fees, expenses or other things of value will be received for the described services rendered to the foreign principal.

The registrant, to support the principal's visit to Washington, D.C., will interact with, exchange communications, and facilitate dialogue and meetings with high-level academia representatives, government officials in charge of health sector and foreign affairs, private sector and international organizations.
