



CONTRACT FOR SERVICES

This contract is entered into between the Embassy of Japan (“the Client”), 2520 Massachusetts Ave. NW, Washington, DC 20008, and Ballard Partners, Inc. (“the Firm”), 601 13th Street NW, Suite 250S, Washington, D.C. 20005.

Recitals

Whereas, the Client wishes to retain the services of the Firm in order that the Firm may provide strategic consulting and advocacy services to the Client in connection with its business with the US Federal government, the US Congress, state legislature and executive agencies of state governments; and

Whereas, the Firm wishes to provide such representation as the Client may from time to time require; and

Whereas, the parties have agreed to the terms under which the Firm will represent the Client and wish to memorialize their agreement in writing.

Now, therefore, in consideration of the mutual covenants herein contained and intending to be legally bound hereby, the parties agree as follows:

1. Term of Agreement. This agreement shall become effective on April 1, 2023 and shall remain effective until June 30, 2023.

2. Duties of The Firm. It shall be the Firm's duty to consult with the Client and advocate on its behalf those issues the Client deems necessary and appropriate before the US Federal government, the US Congress, state legislature and executive agencies of state governments. Issues and objectives may include, but are not limited to, enhancing US-Japan bilateral relations, developing trade, investment, and business opportunities. The Firm also provides Strategic Communications services through its Ballard Media Group and those services are not included as part of this Agreement.

3. Duties of The Client. It shall be the Client's duty to provide the Firm the information necessary to best represent the Client. It shall also be the Client's duty to timely compensate the Firm for its services.

4. Compensation. The Firm shall receive from the Client \$25,000 per month for the Firm's services under this agreement, plus the reasonable out-of-pocket costs associated with the representation, including but not limited to, necessary registration fees; and travel expenses such as hotel, air fare, car services and meals, excluding costs typically associated with the operation of an office such as overhead, staff, and

equipment. The fee shall be paid in monthly installments of \$25,000 a month, beginning April 1, 2023, and continuing to be due within thirty (30) days of receipt of an invoice from the Firm until the termination of the agreement. The Firm will bill its costs monthly.
