

# Sweepstakes Official Rules

**NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.**

## 1. Eligibility

The Father & Son Team Classic Giveaway Sweepstakes is open only to individuals (i) residing in one of the 50 United States or the District of Columbia, (ii) 18 years old or older (unless your state has a greater age of majority, in which case you must be at least that age), (iii) who are registered members of the Freebirdee Web Site, and (iv) in compliance with the Web Site Terms of Use located at [www.freebirdee.com/tos](http://www.freebirdee.com/tos) (the "Terms of Use"). (Entrants may be required to prove their age and residency, the sufficiency of any such proof to be determined by Freebirdee, in its sole discretion.). ## 3. Timing

The Promotion begins on June 4, 2012 at 3 pm Eastern Time ("ET") and ends on June 25, 2012 at 11:59PM ET (the "Sweepstakes Entry Period"). Freebirdee's computer is the official time keeping device for this Promotion.

## 4. How to Enter

To enter this Sweepstakes one must submit all requested information via online electronic submission so that it is received by Freebirdee within the applicable Sweepstakes Entry Period. ## **6.Odds of Winning**

The winner(s) will be determined by random drawing from among valid entries received from eligible participants. The odds of winning a prize depend on the number of valid entries received from eligible participants during the Sweepstakes Entry Period. In the event of a tie for the share prize, the share prize winner will be determined by random drawing consisting of all entrants tied for the lead.

## **7. Verification and Notification of Potential Grand Prize Winner**

## **8. Release**

By entering this Sweepstakes, entrant agrees to release and hold harmless Freebirdee and Sponsor, and their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, and each of their respective parent companies and each such company's officers, directors, employees and agents (collectively, the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Promotion or receipt or use or misuse of any prize. Sponsor and/or Freebirdee reserve the right in their sole discretion to disqualify any individual they find to be tampering with the entry process or the operation of the Sweepstakes or to be

acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor and/or Freebirdee reserves the right to seek damages from any such person to the fullest extent permitted by law. Freebirdee's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

## **12. Disputes**

#### **14. Specific Prize Conditions; Liability for Taxes**
