We had 67 CASAs in 2020, so chances are pretty good you know a CASA or have passed one on the street. IF you have ever met a teacher, you have met a hope giver; a physician, counselor, dependency or family court judge, or foster parent... all hope givers. The organizations that our CASAs are blessed to work with, such as Abbott House, Avera Behavioral Health, Children's Home Society, Department of Social Services, Falls Academy, Lutheran Social Services, Our Home, and so many more... All hope givers. Each of us works in different departments, providing vastly different services. Still, we are all part of the same group of people giving hope, providing a voice, standing in the gap for babies, toddlers, children, youth, and parents giving our time and hearts to make children's lives better, safe, hopeful.

Therefore, don't lose heart at the injustices you know are in the world; for every injustice, someone will rise to fight against it. That someone could even be you.

More than ten abused and neglected children in our area need a CASA volunteer, but their needs are virtually invisible, which is part of the problem. CASA (Court Appointed Special Advocates) volunteers speak up for children in the court system due to parental allegations of abuse or neglect. These CASAs are highly trained and motivated to make a difference in our community, one child at a time. CASAs are experts on the children

they are appointed to, as they are the only people dedicated solely to speak up for the child. There are many other individuals involved in the case. The CASA is the only adult solely dedicated to seeking the child's best interest, safe and permanent home as quickly as possible. CASAs interact with all aspects of the child's life, educational, psychological, medical, dental, familial, etc. While the CASA interacts in the court system and writes reports entered into the legal record, they are not experts in the law. CASAs do not have to possess any particular skill to be a CASA. They have to care about kids, be motivated to speak up when they see something is lacking for that child, and communicate effectively and professionally with many people. Most importantly, CASAs have to have hope that they can make things even just a little bit better for a child in our community. And that is what our fantastic superhero CASA volunteers do every day.



A trained CASA volunteer investigates the child's circumstances, provides fact-based information and makes recommendations to the court while becoming a source of support for the child.

Ultimately, the role of the CASA is to decrease the amount of disruption in a child's life and to help ensure that the child has a safe and permanent home.



First Circuit CASA's goal is to ensure safety and permanency for children whose lives are in turmoil. Our ultimate goal would be that we are able to advocate on behalf of 100% of the abused and neglected children in our iurisdiction.
